## EC/Slovenia interim agreement of cooperation

OBJECTIVE: conclusion of an interim agreement on trade and trade-related measures between the European Communities and Slovenia. SUBSTANCE: The proposal for a Decision aims at concluding an interim Agreement on trade and trade-related matters between the Community, the ECSC and EURATOM of the one part and Slovenia, of the other part. The purpose of this interim agreement is solely to permit the early implementation of the provisions of the Europe Agreement concluded with Slovenia on 10 June 1996 covering the free movement of goods, payments, capital and competition. The Interim Agreement will be valid only until the Europe Agreement enters into force. It will be concluded by the Council on behalf of the Community after consulting Parliament (pursuant to Article 113 in conjunction with Article 228(2), first sentence of the EC Treaty. ?

OBJECTIVE. conclusion of an interim agreement on trade and trade-related measures between the Communities and Slovenia. COMMUNITY MEASURE: Council and Commission Decision 96/752 EURATOM, ECSC, EC on the conclusion of the Interim Agreement on trade and trade-related matters between the European Community, the European Coal and Steel Community and the European Atomic Energy Community, of the one part, and the Republic of Slovenia, of the other part. SUBSTANCE: This Decision aims at concluding an Interim Agreement on trade and trade-related matters between the Community, the ECSC and Euratom, of the one part, and Slovenia, of the other part, in order to permit the early implementation of certain provisions of the Europe Agreement concluded with Slovenia on 10 June 1996. The Interim Agreement will allow the provisional implementation of the provisions on the free movement of goods, payments, capital and competition, and will be valid until the Europe Agreement enters into force. ENTRY INTO FORCE: following notification by Slovenia to the Secretary-General of the Council, the Council and the Commission have decided that the Interim Agreement will apply provisionally from 1 January 1997. ?
