Approximation of the laws relating to fertilizers (amend. Directives 76/116/EEC, 80/876/EEC, 89/284/EEC, 89/530/EEC)

OBJECTIVE : to amend Directives 76/116/EEC, 80/876/EEC, 89/284/EEC and 89/530/EEC on the approximation of the laws of the Member States relating to fertilizers. SUBSTANCE : the proposal amends the Council Directives referred to above by replacing the term 'EEC fertilizer' by 'EC fertilizer'. The packaging, labels and accompanying documents marked 'EEC fertilizer' can continue to be used until 31 December 1998. It is planned that after adoption of this proposal, the amendment will be incorporated in the proposal for legislative consolidation which will then be before the Council. ?

The Economic and Social Committee agrees with the Commission's proposal amending the abovementioned Council directives, since it considers that it is not advisable to use out-of-date markings on packages, labels and accompanying documents. ?

OBJECTIVE: to amend Directives 76/116/EEC, 80/876/EEC, 89/284/EEC and 89/530/EEC on the approximation of the laws relating to fertilizers. COMMUNITY MEASURE: European Parliament and of Council Directive 97/63/EC. SUBSTANCE: the amendments made to the Council directives referred to above seek to replace the term 'EEC fertilizer' with the term 'EC fertilizer'. The packaging, labels and accompanying documents marked 'EEC fertilizer' may continue to be used until 31 December 1998. There is provision that after adoption of the proposal the modification will be included in the proposal for codification which will then be pending before the Council. ENTRY INTO FORCE: 07/12/1997 DEADLINE FOR TRANSPOSITION: 01/07/1998. ?
