## EC/Senegal fisheries agreement: fishing off the coast, extension of the protocol for the period from 2 October 1996 to 1th November 1996

OBJECTIVE: to conclude an Agreement in the form of an exchange of letters between Senegal and the Community with a view to extending by one month (2 October 1996-1 November 1996) the current EC-Senegal Fisheries Protocol. SUBSTANCE: this extension is needed so that negotiations can continue without any suspension of fishing by Community vessels, of which there are over 60, in Senegal's waters. ?

## EC/Senegal fisheries agreement: fishing off the coast, extension of the protocol for the period from 2 October 1996 to 1th November 1996

By adopting the report by Mrs Nicole PERY (PSE, F), the European Parliament approved retrospectively the extension for one month (2 October - 1 November 1996) of the fisheries agreement between the EU and Senegal. This extension will have enabled some Community vessels affected by the biological resting period in Mauritanian waters to fish off Senegal during that period.?

## EC/Senegal fisheries agreement: fishing off the coast, extension of the protocol for the period from 2 October 1996 to 1th November 1996

OBJECTIVE: conclusion of an Agreement in the form of an exchange of letters between Senegal and the Community to extend for one month (02.10.1996 to 01.11.1996) the protocol on fishing off the coast of Senegal in force until the former date. COMMUNITY MEASURE: Council Decision 97/531/EC on the conclusion of an Agreement in the form of an exchange of letters concerning the interim extension of the Protocol

to the Agreement between the European Economic Community and the Government of Senegal on fishing off the coast of Senegal for the period from 2 October 1996 to 1 November 1996. SUBSTANCE: the extension of the protocol is approved on behalf of the Community. The financial compensation to be paid by the Community during the period concerned is to be calculated in relation to the quantities of fish caught and the measures laid down in the Protocol between the EC and Senegal. The payment of the contribution is to be made before 31.12.1996 in the same way as provided for in the initial protocol. ENTRY INTO FORCE: the interim protocol is to enter into force as soon as all the necessary notifications have been made.?
