## Common transport policy: promotion of sustainable and safe mobility

OBJECTIVE: the promotion of sustainable and safe mobility for persons and goods in the internal market. SUBSTANCE: the proposal for a Council Decision deals with the definition and implementation of the common transport policy and the transeuropean transport network in order to ensure and promote sustainable and safe mobility. It concerns only significant actions which the Commission could undertake for the establishment and development of the common transport policy and for the promotion of transport safety. Certain significant actions can be financed from item B2-702 'transport safety' and B2-704 'establishment and development of a sustainable transport policy' for which the appropriations have regularly exceeded ECU 5 million since 1993. They mainly concern clearly identifiable but highly diverse operations conducted by third parties, more often than not public or private international organizations, engaged in publicizing the objectives pursued by the Community in the transport sector. The financing of these operations normally takes the form of subsidies not exceeding 50% of the total cost of the project, save in exceptional circumstances, although other actions may be conducted directly and exclusively by the Commission. ?

## Common transport policy: promotion of sustainable and safe mobility

The Economic and Social Committee welcomes the proposed Council decision insofar as it should prompt the Commission to make more intensive and purposeful use of the funds made available by the Parliament so that the problems associated with the transport of goods and people are solved as quickly as possible. The Committee thinks that it is vital for the Commission to be provided with the requisite funds and the legal basis for implementing the measures listed in Articles 2 and 3 of the proposal. It is also in the general interest for the Commission to be able to collect authoritative evidence by commissioning studies and analyses from independent experts. The Economic and Social Committee also welcomes the binding provision contained in Article 4 stipulating that each final payment is to be preceded by a detailed check on the services provided, taking into account the contractual obligations entered into by the beneficiary and the principles of basic economics and sound financial management. Finally, the Economic and Social Committee eagerly awaits the first Commission report due out in 2001 on the use made of the appropriations and the evaluation of their contribution towards the achievement of the objectives pursued by the Community (cf. Article 6 of the proposal). ?
