## EC/Armenia agreement: interim agreement on trade and trade-related matters

**OBJECTIVE:** conclusion of an Interim Agreement on trade and trade-related matters between the European Communities and Armenia.

**SUBSTANCE:** the object of the proposed Decision is to conclude an Interim Agreement between the European Community, the ECSC and Euratom, of the one part and Armenia of the other part, on trade and trade-related matters. The Interim Agreement provides for provisional implementation of that part of the Partnership and Cooperation Agreement on trade and trade-related measures which was concluded between the European Communities and that country (Agreement initialled on 22 April 1996) and will be applicable until the entry into force of the Partnership and Cooperation Agreement. The Interim Agreement replaces, as far as Armenia specifically is concerned, the trade-related provisions of the Agreement on trade and commercial and economic cooperation concluded in 1989 between the European Community and the USSR. The Council will conclude the Agreement on behalf of the European Community, after consulting the European Parliament, under Article 113, in conjunction with Article 228(2), first sentence of the EC Treaty. ?

## EC/Armenia agreement: interim agreement on trade and trade-related matters

In unanimously adopting the report by Peter KITTELMANN (EPP, D), the Committee is urging the European Parliament to say yes to the interim agreement between the EU and Armenia on trade and flanking measures. The agreement would allow early implementation of the trade provisions of the partnership and cooperation agreement between the EU and Armenia, signed on 22 April 1996. The interim agreement needs to be ratified only by the institutions of the Union, whereas the partnership agreement, which provides for broader cooperation on foreign policy and cultural affairs, must be ratified by the Member States as well as the Union.

OBJECTIVE: conclusion of an Interim Agreement on trade and trade-related matters between the European Communities and Armenia. COMMUNITY MEASURE: Council Decision 97/300/ECSC, EC, Euratom on the conclusion by the European Community of the Interim Agreement between the European Community, the European Coal and Steel Community and the European Atomic Energy Community, of the one part, and the Republic of Armenia, of the other part, on trade and trade-related matters. SUBSTANCE: the Interim Agreement provides for provisional implementation of that part of the Partnership and Cooperation Agreement on trade and trade-related measures which was concluded between the European Communities and that country on 22 April 1996 and will be applicable until the entry into force of the Partnership and Cooperation Agreement. It replaces, as far as Armenia specifically is concerned, the trade-related provisions of the Agreement on Trade and Commercial and Economic Cooperation concluded in 1989 between the European Communities and the USSR. ENTRY INTO FORCE: the Decision enters into force on 29 April 1997. The Agreement will enter into force once the parties have given each other the requisite notifications.?
