## 1995 discharge: European Centre for the Development of Vocational Training ECDVT budget

Similarly, although the 1994 discharge for CEDEFOP (European Centre for the Development of Vocational Training) in 1994, the Committee on Budgetary Control unanimously approved the report by Edward KELLETT-BOWMAN (EPP, UK) which proposed granting a discharge for 1994 and 1995. The committee has some doubts about the agreement between CEDEFOP and the Greek Government on the construction and purchase of buildings in Thessaloniki. It has also noted that difficulties concerning staff relocation from Berlin to Thessaloniki, for which the Council bore prime responsibility, should be settled during 1997. The Committee on Budgetary Control also unanimously approved the KELLETT-BOWMAN report on granting a discharge for 1995 to the European Foundation for the Improvement of Living and Working Conditions in Dublin.?
