EC/Uzbekistan agreement: interim agreement on trade and trade-related matters

OBJECTIVE: interim agreement on trade and trade-related matters between the European Community and Uzbekistan. SUBSTANCE: the aim of the proposal is the adoption of an interim agreement providing for provisional implementation of the trade and trade-related measures of the Partnership and Cooperation Agreement between the Community and Uzbekistan initialled on 21 June 1996. The present agreement is being adopted pending, and will apply until, the definitive entry into force of the main Partnership Agreement. ?

The committee unanimously approved the draft legislative resolution with Parliament's assent to the approval of the draft interim agreement in question. The rapporteur, Mr WIERSMA (PSE, N) considered that Commissioner Van den Broek's positive response to Mrs Castellina's letter asking for his involvement, so that the joint committee for the agreement could also deal with questions relating to human rights and democracy, gave to understand that once the agreement had been concluded, the European Union would have additional leverage in its efforts to contribute to political reform in Uzbekistan. ?

OBJECTIVE: interim agreement on trade and trade-related matters between the European Community and Uzbekistan. COMMUNITY MEASURE: Council Decision 98/138/EC on the conclusion by the European Community of the interim agreement on trade and trade-related matters between the European Community, the European Coal and Steel Community and the European Atomic Energy Community of the one part and the Republic of Uzbekistan of the other part. SUBSTANCE: the decision seeks to adopt an interim agreement concerning the provisional application of the section of the partnership and cooperation agreement initialed on 21 June 1996 between the European Community and Uzbekistan concerning trade and trade-related matters. This agreement has been adopted pending the definitive entry into force of the partnership agreement and will cease to apply once the principal agreement enters into force. ENTRY INTO FORCE : 01.06.1998.?
