## Agricultural prices 1997/1998: intervention price for adult bovine animals

Agricultural prices 1997/98 - beef The Commission proposes maintaining the intervention price for adult bovine animals at ECU 347.5/100kg deadweight for male animals in the category R3. It is unnecessary to fix other prices as the Council has removed the obligation to fix a guide price each year (Uruguay Round agreement). ?

Agricultural prices 1997/98 - Beef and veal (intervention price for large bovines). Adopting the report by Mr Robert STURDY (PPE, UK), Parliament approved the proposed regulation without modification. ?

## Agricultural prices 1997/1998: intervention price for adult bovine animals

Prices for agricultural products 1997/98 - bovine animals. The Council adopted Regulation (EC) No 1191/97 fixing the intervention price for adult bovine animals for the 1997/98 marketing year. SUBSTANCE: the status quo with regard to the intervention price for adult bovine animals was to be maintained for the period from 1 July 1997 to 30 June 1998, i.e. a price of 347,5 ECU/100 kg for carcasses of male animals in category R3; there was no need to fix any other prices. It is worth noting that, when the report on the functioning of the system of premiums in the veal sector is considered, a reduction in the processing premium in respect of calves could be considered. The Council calls on the Commission, in connection with its continuous management of the market, to ensure that the intervention regime operates so as to support production prices effectively. In this respect, the Commission is called upon to consider as a matter of urgency the application of Regulation (EEC) No 2456/93 with a view to preventing a downward price spiral. ?
