Agricultural prices 1997/1998 - Sheep meat and goat meat. Adopting Regulation (EC) No 1416/97, the Council decided not to change the basic price (ECU 504.07/100kg carcass weight) or the seasonal adjustment. The Council asked the Commission to submit the report on ewe premiums requested in December 1996 by 31 December 1997 and to include any proposals needed. The Commission was called on to present a proposal to increase the percentage applied to the "rural society" premium paid in less-favoured areas for milk ewes and goats from 70% to 90%. ?
