## Agricultural holdings: network of accountancy data on the incomes and business operation (amend. Regul. 79/65/EEC)

---

OBJECTIVE: the proposal seeks to amend Regulation 79/65/EEC setting up a network for the collection of accountancy data on the incomes and business operation of agricultural holdings in the Community. SUBSTANCE: Article 15(1) of Regulation 79/65/EEC prohibits the use, for taxation purposes, of any individual accountancy data from agricultural holdings or other individual details obtained in implementation of that Regulation. It is proposed to reinforce those provisions in order to prohibit any use or divulgence of data supplied by farmers except for the purposes referred to in Article 1 of that Regulation, in other words, for the annual determination of incomes on agricultural holdings coming within the field of the survey and for a business analysis of agricultural holdings. ?

OBJECTIVE: to amend Regulation (EEC) No 79/65 setting up a network for the collection of accountancy data on the incomes and business operations of agricultural holdings in the Community. COMMUNITY MEASURE: Regulation (EC) No 1256/97 amending Regulation (EEC) No 79/65. SUBSTANCE: the network in question was already governed by the rule that the accountancy data and other individual information relating to agricultural holdings could not be used for taxation purposes; the purpose of the amendment was to strengthen these provisions, prohibiting any use of the data for purposes other than those specified in the Regulation. DATE OF ENTRY INTO FORCE: 09/07/1997. ?
