Internal market SLIM: results of the 2nd phase and follow-up of the implementation of 1st phase. Report

The present working document summarizes the progress achieved in implementing the recommendations made during the first phase of the SLIM initiative (Simple Legislation for the Internal Market), launched by the Commission in May 1996. It also describes the areas selected for a second phase, explains the reasons behind the selection, sets out a timetable and describes some of the practical aspects of the SLIM teams' work. The progress in implementing the recommendations made during the first phase can be summarized as follows: 1) Intrastat: the recommendations of the Intrastat team included simplifying or no longer collecting certain data as from 1 January 1998, substantially reducing the number of subheadings in the nomenclature to be used from that date, and launching studies with a view to modifying the collection system or introducing a new one to reduce the burden on businesses. The Commission remains committed to the need for a simplified nomenclature. It has held discussions with an advisory group comprising Member State and industry representatives, with the aim of drafting a proposal by June 1997 which would take account of the needs of data users and providers. As far as simplification of data collection is concerned, the Commission is due to adopt two draft regulations amending Regulation No 3330/91/EEC soon. 2) Ornamental plants: the SLIM team is unanimous as regards the need to simplify and clarify the existing text. There should be differing forms and degrees of control at different stages of the production/distribution process, the rules applicable to the species covered should take account of their economic importance, the rules on varietal authenticity should be clarified, and the regime governing imports from third countries should be reviewed. The Commission will present a draft revised directive in May 1997, in which these aspects will be addressed and the text generally simplified . 3) Construction products: the option favoured by the Commission is to combine a short-term acceleration in the setting of standards with a long-term revision of the Directive, in order to bring it into line with the principles of the 'new approach'. The Commission has already initiated work to speed up the setting of standards. 4) Recognition of diplomas: the Commission will present proposals before the end of the year with a view to simplifying the updating of lists of diplomas which benefit from automatic recognition and streamlining the advisory committees. A hearing with interested parties will be held towards the end of the year. The Commission also intends to carry out an investigation into the administrative and legal formalities surrounding the recognition procedure under the sectoral directives; a similar exercise is already under way for the general system. Regarding the selection of areas, it has been agreed that Phase II of SLIM should cover the following sectors: value-added tax obligations, banking services, the combined nomenclature for external trade, and fertilizers. The teams will begin work in May 1997 and will deliver their reports by the end of October. The conclusions and recommendations contained in these reports will be the subject of a Commission Communication to the Internal Market Council in November. ?

Internal market SLIM: results of the 2nd phase and follow-up of the implementation of 1st phase. Report

This communication summarizes the recommendations of the SLIM teams on the four sectors discussed in the second phase of the measure (VAT obligations, the Combined Nomenclature for External Trade, banking services and fertilizers) and the Commission's position on these recommendations. It informs the Council and the European Parliament of the progress made in implementing the recommendations of the

SLIM teams during the previous phase. Concerning the implementation of the first phase, the Commission emphasizes that the problems which have arisen in the implementation of the Intrastat recommendations show that there is a contradiction between the political determination to simplify, repeatedly expressed by the Internal Market Ministers and the reluctance to adopt simpler data collection procedures and a simplified nomenclature for internal trade. The SLIM teams comprise five experts from national administrations and five representatives of users of the legislation. They started their work in June 1997 and submitted their reports at the end of October 1997.?

Internal market SLIM: results of the 2nd phase and follow-up of the implementation of 1st phase. Report

The Committee has unanimously adopted the report by Brian CROWLEY (UFE, Irl) on simplifying legislation on the internal market (known as "SLIM"). The aim of the report was to examine the results of the second phase and the follow-up of implementation of the first phase recommendations. The first phase of SLIM (June-October 1996) examined four sectors: · Intrastat, · recognition of diplomas · construction products · ornamental plants. The second phase (June-October 1997) examined four more sectors: · VAT obligations · the Combined Nomenclature for External Trade · fertilisers · banking legislation. Two new phases are planned for this year. In its motion for a resolution, the committee stresses the importance of using clearer language for Community legislation. SLIM is not to be regarded as an isolated simplification exercise, but rather as an element within a larger "rolling programme of simplification". The committee believes that the working party set up to establish common guidelines for legislative work must be common to all the institutions and that the SLIM teams should be granted a longer working period (minimum 6 months). The committee welcomes the inclusion of the banking services sector in the initiative. As regards Intrastat, it believes that a single set of nomenclature should be used (for both the internal market and trade outside the EU). For the third phase of the project, the committee proposes that the following sectors be chosen: · freedom of movement and social security for migrant workers · health and safety at work · public procurement · marketing of dangerous substances. Lastly, the committee calls on the Commission, acting through its offices in the 15 Member States, to react vigorously when governments use the EU as a scapegoat for unpopular national rules.?

In adopting the report by Mr Brian CROWLEY (UPE, Irl) the European Parliament urges the Commission to extend the scope of the SLIM method to all legislative areas in the Community, in particular the new legislation concerning agriculture. It believes that the Commission should endorse at an early date most of the recommendations made regarding the sectors examined in the second phase of the SLIM. Parliament proposes that the Commission select the following sectors for project's third phase: freedom of movement and social security for migrant workers, health and safety at work, public procurement and the directive on the marketing of dangerous substances. The fourth phase should include the machinery directive, the environmental waste management directive, the telecommunications equipment directive and the electromagnetic compatibility directive and the implementation of pollution controls. Parliament also advocates a simplification programme which covers the legislation of the individual Member States concerning governing the transposition of Community legislation into national law.
