EC/Mauritania fisheries agreement: cooperation agreement in the sea fisheries sector

OBJECTIVE: to amend certain technical and financial provisions of the Agreement concerning cooperation in the sea fisheries sector concluded between the Community and Mauritania in 1996. SUBSTANCE: the amendments concern: -technical points regarding fishing for cephalopods and pelagic fishing (fishing zones, authorized gear and mesh sizes, tonnages and numbers of vessels authorized to fish by period and fees in ECU per annum), -granting of quarterly licences to pole-and-line tuna vessels and surface longliners, -the contribution to the cost of scientific observation for pelagic vessels.?

EC/Mauritania fisheries agreement: cooperation agreement in the sea fisheries sector

The Committee adopted the report by Mr IMAZ SAN MIGUEL (PPE, E) on the amendment of the Agreement on cooperation in the sea fisheries sector with the Islamic Republic of Mauritania. The changes envisaged in the Agreement under review were not such that they would require Parliament's assent, since they could not be considered to have 'important budgetary implications'.?

Adopting the report by Mr Josu Jon IMAZ SAN MIGUEL (PPE, E), the European Parliament approved the amendment to the agreement on cooperation in the fisheries sector concluded between the Community and Mauritania. However, it reiterated that the legal basis for the

conclusion of the agreement called for the assent of the European Parliament. However, as the proposed changes did not have any "important budgetary implications", the assent procedure could be dispensed with in this case.?

OBJECTIVE: amendment of certain technical and financial provisions of the agreement on cooperation in the fisheries sector concluded between the Community and Mauritania. COMMUNITY MEASURE: Council Regulation 2399/97/EC concerning the conclusion of the Agreement in the form of an Exchange of Letters amending the Agreement on cooperation in the sea fisheries sector between the European Community and the Islamic Republic of Mauritania. SUBSTANCE: the agreement in the form of an exchange of letters concluded between the parties modifies the following points in the basic agreement: - technical aspects relating to fishing for cephalopods and pelagic fishing (fishing zones, authorized gear and mesh size, authorized tonnage and number of vessels per period and fees in ECU per year, biological recovery), - quarterly licences to be obtained by pole-and-line tuna vessels and surface longliners, - contribution to the cost of scientific observation for pelagic vessels (owners who are in possession of a licence must contribute ECU 350 per month per vessel). ENTRY INTO FORCE: the regulation entered into force on 5 December 1997. ?
