Type-approval of motor vehicles and trailers transporting animals

OBJECTIVE: the objective of the proposal for a Directive is to establish the technical requirements for motor vehicles and their trailers intended for the transport of certain types of animals to safeguard animal welfare during transport. SUBSTANCE: In view of the increasing use of vehicles and their trailers intended for the transport of certain types of animals, it is proposed that special provisions be laid down at European level, within the framework of the European type-approval system, governing ventilation, loading and unloading facilities, floor capacity, side-wall construction, and accessibility of the load compartment. The proposal for a Directive is a separate directive within the meaning of the European type-approval system. Compliance with all relevant technical requirements will ensure free circulation for the vehicles concerned within the internal market. The Directive will also be based on optional harmonization. Member States may either require that only the prescriptions of the separate Directive shall apply or alternatively they may maintain national legislation, in which case the manufacturer can choose between this and the harmonized requirements. The proposal for a Directive does not affect national or Community legislation concerning the use of such vehicles.?

Type-approval of motor vehicles and trailers transporting animals

The ESC therefore approves the principle but sees a number of problems with the execution. These problems are caused by the Commission trying to separate use and construction requirements. As an example: Simultaneously with this proposal, another part of the Commission has issued a proposal under Article 43 (COM(97) 272) giving additional standards for vehicles transporting animals for over eight hours. This contains a number of mandatory constructional requirements such as 200 litre water storage tanks which are not present in the type specification proposal. The effect is that the type specification only applies to vehicles used for journeys below eight hours. For all others national specifications will continue to apply. That is an illustration of the problems arising from trying to separate use and construction specifications. Use and construction specifications therefore must be concordant and established in parallel. This also applies to other proposals which we understand are currently being elaborated. To be of any real benefit a type specification must cover at least the majority of vehicles involved. Given the large range of uses and of climatic conditions the ESC recommends that this proposal is kept on hold until the use requirements have been, as soon as possible, established. It should then be complemented by separate annexes giving essential type-approval requirements for vehicles used on long journeys, in extreme climatic conditions, etc. ?

Type-approval of motor vehicles and trailers transporting animals

The Committee adopted the report of Ms. Heidi HAUTALA (Greens, FIN), that calls for substantial changes to a Commission proposal on technical requirements for vehicles and trailers for transport of certain animals. With its proposal, the Commission seeks to ensure that such vehicles are constructed in such a way such as to alleviate as far as possible the considerable stress suffered by the 14 million animals transported each year between the Member States. With its amendments, the Committee is seeking to further strengthen the protection of animal welfare. Noting that most stress is suffered by animals during loading and unloading, the rapporteur had introduced a series of amendments aiming at facilitating this process by calling for less steep loading ramps, as well as calling for a wider use of loading lifts. Other amendments adopted by the Committee calls for a constant monitoring of the temperature and humidity within the livestock compartment so that animals do not suffer unacceptable conditions. Finally, to remedy what the rapporteur described as a serious omission in the proposal, the Committee adopted amendments introducing a mandatory requirement to re-inspect animal transport vehicles at least every three years to ensure that they continue to meet the requirements laid down in the current proposal. ?

Type-approval of motor vehicles and trailers transporting animals

The rapporteur said that Parliament should take advantage of the codecision procedure to improve the situation of animals, even if technical standards did not allow all the problems to be resolved. Commissioner Bangemann emphasised that the issue under debate was the type-approval procedure for vehicles used to transport animals and not the monitoring of animals. He said that the Commission could accept 9 of the 24 amendments tabled: these were Amendments Nos 3, 4, 6, 14 and 17 to 21, including one requiring any unit transporting pigs to have a loading lift.

Type-approval of motor vehicles and trailers transporting animals

In adopting the report by Mrs Heidi HAUTALA (Greens, FIN) Parliament advocated substantial changes in the Commission proposal relating to the technical provisions applicable to motor vehicles and their trailers transporting certain animals. With the amendments adopted Parliament sought to strengthen further the protection of animal welfare. Noting that the animals suffered most stress during loading and unloading, Parliament introduced a series of amendments seeking to facilitate these operations through less angled loading ramps (ramp angle of not more than 20°) and more frequent use of loading lifts. Other amendments adopted called for continuous monitoring of temperature and humidity in the livestock compartment so that the animals do not have to suffer intolerable conditions. Lastly, to remedy what Parliament considered to be a serious omission in this proposal, it proposed amendments providing for a reinspection of vehicles intended for the transport of animals every three years to ensure that they conformed to the provisions adopted. ?

Type-approval of motor vehicles and trailers transporting animals

The Commission's amended proposal retains nine of the European Parliament's amendments. The new formulation provides for greater flexibility for manufacturers in terms of the choice of technical solutions to be employed. In terms of the amended proposal, a ramp or a loading lift has to be part of the transport unit for lambs. For pig transport, all the transport units have to possess a loading lift. This technical solution is required to avoid excessive stress on the animals.?

Type-approval of motor vehicles and trailers transporting animals

The European Parliament confirmed as first reading the text adopted on 16.07.1998 concerning a proposal for a Directive relating to motor vehicles and their trailers transporting certain animals, the numbering of the legal base of which has changed due to the entry into force of the Amsterdam Treaty.?

Type-approval of motor vehicles and trailers transporting animals

As this proposal is no longer of topical interest, it has been withdrawn by the Commission.
