KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

OBJECTIVE: to extend for two years (until December 1999), in its present form, the Karolus programme of exchanges between Member State administrations of officials responsible for implementing Community legislation, and to extend the programme to the Central and Eastern European associated countries and to EFTA countries which are EEA members and Cyprus. SUBSTANCE: Pending a complete overhaul of the programme, the Commission proposes extending the Karolus programme for two years (from 01.01.1998 to 31.12.1999), in accordance with the programme management committee's desire for a transitional period before the programme is altered. The extension can be carried out without any extra resources, as the amount laid down in Decision 92/481/EEC setting up the Karolus programme has not been completely exhausted. In parallel, the proposal calls for the programme to be extended to: - associated CEECs in accordance with the conditions laid down in the additional protocols to the association agreements concerning participation by these countries in Community programmes, - EFTA countries which are EEA members and Cyprus, on the basis of additional appropriations and in accordance with arrangements to be agreed with the countries concerned.?

KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

The rapporteur, Mr VON WOGAU (EPP, D), approves the Commission's proposal for extending the Karolus programme by two years. The amendments proposed by the rapporteur mainly concern the planning of the annual budget and comitology. The extension of the programme up to the end of 1999 should not entail new expenditure, insofar as the resources provided for in 1992 have not all been used. As it is proposed, Karolus will henceforth be directed as much at the public sector as at employees in the private sector within the European Union and associated countries (including the CEE countries). ?

KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

In adopting the report by Mr Karl von WOGAU (PPE, D), the European Parliament has approved the two-year extension of the KAROLUS programme (exchange of officials). It has proposed the following changes to the budgetary planning of the programme: - appropriations for 1993-1997 to amount to ECU 7.7 million, - the budget for 1998-1999 to be fixed at ECU 4.5 million. The aggregate amount of ECU 12.2 million would correspond to an overall figure of 1 900 participants. Parliament also proposes changes to the committee arrangements, with an advisory committee replacing the one originally envisaged. ?

KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

In its amended proposal, the European Commission has accepted most of the amendments adopted by Parliament at first reading. These relate primarily to the consolidation of participation in the programme and to budgetary planning for KAROLUS: appropriations for KAROLUS for 1993-1997 will amount to ECU 7.7 million, appropriations for 1998-1999 will amount to ECU 4.5 million. The aggregate amount of ECU 12.2 million will correspond to a total of 1 340 participants. The Commission has not accepted Parliament's amendments concerning comitology. ?

KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

The Economic and Social Committee frequently saw that differences in interpretation and application of single market legislation created more problems for businesses than any other factor. The Committee therefore endorsed without reservation the Commission's proposals to extend the Karolus programme for a two-year transitional period, to widen its application during that period to other specified states and to develop a modified programme with a wider scope, and with possible participation of the workers, to take the place of the existing programme at the end of the transitional period.

KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

In its common position on the extension of the KAROLUS programme, the Council has incorporated as it stands the Commission's amended proposal, which took on board almost all the amendments adopted by the European Parliament at first reading. In particular, the Council has incorporated the amendments relating to the budgetary planning of the programme (ECU 12.2 million over 7 years) and the overall number of participants in KAROLUS (i.e. 1,340 participants). Only the amendment concerning comitology (which had been rejected by the Commission in its amended proposal) was rejected by the Council.?

In its opinion on the common position of the Council on the KAROLUS programme, the Commission stated that it fully supported Council's text.?

KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

The committee approved the Council common position on the proposed two-year extension of the community programme Karolus for promoting confidence and uniform application of EU legislation through exchange of national officials involved in the implementation. Following a proposal from the rapporteur Mr Karl VON WOGAU (EPP, D), the Committee adopted the text under the procedure without report as the Council has taken onboard most of Parliament's amendments from the first reading.

The European Parliament adopted the recommendation for second reading (procedure without report) concerning the extension of the KAROLUS programme, unamended.?

KAROLUS programme: exchange of national officials between administrations (amend. Dec. 92/481/EEC)

OBJECTIVE: to extend for a further two years the Karolus programme and extend the programme to the associated countries of Central and Eastern Europe, the EEA countries and Cyprus. COMMUNITY MEASURE: European Parliament and Council Decision 889/98/EC amending Council Decision 92/481/EEC on the adoption of an action plan for the exchange between Member State administrations of national officials who are engaged in the implementation of Community legislation required to achieve the internal market (Karolus programme). SUBSTANCE: The purpose of the present Decision is to extend the Karolus programme by two years (from 01.01.1998 to 31.12.1999) before the programme is completely revised. This extension is being made without increasing the budget, as the amount provided for in Decision 92/481/EEC setting up Karolus has not been completely exhausted. However, a new budgetary schedule is proposed, as follows: 1) from 1993 to 1997, the appropriations for Karolus are set at ECU 7.7 m, 2) from 1998 to 1999, they are set at ECU 4.5 m. The cumulative amount of ECU 12.2 m corresponds to an overall figure of 1340 participants. The Decision also extends the programme: -to the associated countries of Central and Eastern Europe, in accordance with the conditions laid down in the additional protocols to the Association Agreements relating to participation by these countries in Community programmes, -to EFTA countries which are members of the EEA and Cyprus, on the basis of additional appropriations, details to be agreed with these countries. ENTRY INTO FORCE: 07.04.1998.?
