Animal feed sector: approbation and registration of establishments and intermediaries

OBJECTIVE: to subject establishments producing nutritional supplements for animals, and their intermediaries, to the same rules as those established under Directive 95/69/EC for the approval of establishments manufacturing pre-mixed products. CONTENT: the current proposal for a directive is restricted to setting the obligations for Member States in respect of rules implementing the approval or registration of establishments and intermediaries producing nutritional supplements for animals.?

Animal feed sector: approbation and registration of establishments and intermediaries

In adopting the report by Mrs Anne-Christine POISSON (UPE, F), the European Parliament endorsed, with a number of modifications, the proposal for a directive seeking to amend the 1995 directive laying down arrangements for approving and registering certain establishments in the animal feed sector. The rapporteur expressed a number of reservations concerning proposals for the registration of users, arguing that the procedure is too cumbersome without providing an improved guarantee. ?

Animal feed sector: approbation and registration of establishments and intermediaries

Article 100a of the Treaty, the rapporteur welcomed the proposed improvements. However, she had reservations about the registration of users of nutritional supplements leading to additional burdensome administrative procedures without this bringing any real practical benefits. This was why, in order to maintain clarity and simplification, she could not accept Amendments Nos 11 and 12 relating to the list of components and their proportions. Commissioner Oreja said that the Commission could accept Amendments Nos 8, 9 and 10 aimed at simplifying the amendment of Directive 95/69/EC as regards the approval and registration of certain establishments and intermediaries operating in the animal feed sector. However, he rejected Amendments Nos 11 and 12.

The amended proposal takes into account the three amendments sought by Parliament, which aimed to simplify the administrative procedure as regards registering stock farmers using nutritional supplements for animals.?

The Directorates General or responsible departments have asked for this proposal to be withdrawn. The reasons are indicated as follows: A) for objective reasons (change of de facto situation, objectives already achieved by other means, etc) B) because the Commission has now adopted another approach: - the proposal is replaced implicitly, - a new proposal is in preparation, - no planned replacement.?
