OBJECTIVE: to grant temporary and limited derogations from specific Community health rules on the production and marketing of certain products of animal origin. COMMUNITY MEASURE: Council Directive 92/120/EEC on the conditions for granting temporary and limited derogations from specific Community health rules on the production and marketing of certain products of animal origin. CONTENT: - Member States may, until 31 December 1995, authorise establishments manufacturing products of animal origin to derogate from some of the requirements laid down in Directive 77/99/EEC; - derogations may be granted only to establishments which have submitted an application for a derogation to the competent national authority; - Member States must notify the Commission of the establishments which comply with the requirements of Directive 77/99/EEC; - the minimum output for slaughterhouses benefiting from the derogation are extended to 20 livestock units per week and 1 000 livestock units per year respectively until 31 December 1994. DEADLINE FOR TRANSPOSITION INTO NATIONAL LEGISLATION: 01/01/1993. ?

Production and marketing of products of animal origin

OBJECTIVE: to amend Directive 92/120/EEC with a view to granting temporary and limited derogations from Community rules on the production and marketing of certain products of animal origin. COMMUNITY MEASURE: Council Directive 94/70/EC amending Council Directive 92/120/EEC. CONTENT: the minimum output for slaughterhouses benefiting from the derogation is fixed at 20 livestock units per week and 1000 livestock units per year respectively until 28 February 1995. DEADLINE FOR TRANSPOSITION INTO NATIONAL LEGISLATION: 1 January 1995.?

Production and marketing of products of animal origin

OBJECTIVE: to amend Directive 92/120/EEC with a view to granting temporary and limited derogations from Community rules on the production and marketing of certain products of animal origin. COMMUNITY MEASURE: Council Directive 95/5/EC amending Council Directive 92/120/EEC. SUBSTANCE: the minimum output for slaughterhouses benefiting from the derogation was fixed at 20 livestock units per week and 1 000 livestock units per year respectively until 30 June 1995. DATE FOR TRANSPOSITION INTO NATIONAL LEGISLATION: 1 March 1995. ?
