### 1988/1989 to 1997/1998 wine years: permanent abandonment premiums of wine-growing areas (amend. regul. 1442/88/EEC)

OBJECTIVE: the proposal for a regulation seeks to increase the quota allocated to Germany for the application of the permanent abandonment premium scheme in respect of wine-growing areas. CONTENT: the number of hectares allocated to Germany (50 ha) has proved to be too small, preventing distribution in line with the requirements of the various wine-growing regions. It is therefore proposed to increase the acreage allocated to Germany by 950 ha. In order to avoid increasing the total maximum surface area provided for in the basic regulation, the quota allocated to Spain will be reduced by 950 ha. ?

### 1988/1989 to 1997/1998 wine years: permanent abandonment premiums of wine-growing areas (amend. regul. 1442/88/EEC)

The Committee welcomes the proposed amendment to Regulation 1442/88/EEC which seeks to increase by 950 ha the quota allocated to Germany. This proposal will make it possible for meaningful use to be made, in Germany too, of the programme for regulating wine-growing areas. ?

### 1988/1989 to 1997/1998 wine years: permanent abandonment premiums of wine-growing areas (amend. regul. 1442/88/EEC)

OBJECTIVE: to increase the quota allocated to Germany for the application of the permanent abandonment premium scheme in respect of wine-growing areas. COMMUNITY MEASURE: Council Regulation (EC) no. 191/98 amending Regulation (EEC) no. 1442/88 on the granting,

for the 1988/1989 to 1997/1998 wine years, of permanent abandonment premiums in respect of wine-growing areas. CONTENTS: this modification, which follows on from the overall agreement on the 1997/98 price proposals, seeks to facilitate the application of the permanent abandonment premium scheme in respect of wine-growing areas throughout the wine-growing regions of Germany, where the number of hectares allocated (50 ha) has proved to be too small, preventing distribution in line with the requirements of the various wine-growing regions, by increasing the acreage by 950 ha. In order to avoid increasing the total maximum surface area, this amendment entails an equivalent reduction in the quota allocated to Spain. ENTRY INTO FORCE: 30 January 1998.?
