### 'Synergy' programme to promote international cooperation in the energy sector: extending the programme until 31 December 1998

OBJECTIVE: to extend for one year the validity of the programme to promote international cooperation in the energy sector (SYNERGY programme). CONTENT: the European Commission will submit proposals by the end of 1997 so that a definitive new programme can be adopted, although this will not be possible before the first half of 1998. This proposal therefore seeks to maintain continuity in the actions started under SYNERGY during 1998, pending their incorporation in a new programme. The financial reference amount proposed is the same as in 1997 and is in keeping with the preliminary draft budget for 1998 presented by the Commission. ?
