EC/Mexico agreement: interim agreement on trade, implementing economic partnership and cooperation agreement

OBJECTIVE: conclusion of an interim trade agreement and accompanying measures between the Community and its Member States, of the one part, and Mexico, of the other part. SUBSTANCE: the aim of the proposal is the adoption of an interim agreement to speed up the implementation of the trade and associated provisions of the agreement on trading partnership, political coordination and cooperation initialled by the Community and its Member States and Mexico on 23 July 1997 (AVC97289) which are the responsibility of the Community. Implementation will allow the parties to enter into negotiations with a view to achieving, at the earliest possible stage, the liberalization of trade as intended by the main agreement.?

EC/Mexico agreement: interim agreement on trade, implementing economic partnership and cooperation agreement

In a supplementary basic document the Council proposes the text of the Final Act of the Interim Agreement on trade and trade-related matters signed by the parties on 8 December 1997 in Brussels, as finalized by the legal linguistic experts. This text also includes all the joint and unilateral declarations of the parties on: - the interpretation of Article 2 of the agreement (setting a timetable and the arrangements for the gradual bilateral reduction of obstacles to trade in goods and services), - the gradual establishment of the general liberalization of trade, - the interpretation of Article 5 of the agreement on the application of Community rules on fair competition.

EC/Mexico agreement: interim agreement on trade, implementing economic partnership and cooperation agreement

The Committee has adopted - almost unanimously - the recommendation by Ana MIRANDA DE LAGE (PES, E) on the interim agreement between the EU and Mexico on trade and trade-related matters. The committee recommends that Parliament give its assent to the agreement. This is a provisional agreement, pending ratification of the agreement on economic partnership, political coordination and cooperation. The interim agreement contains a joint declaration in which both parties undertake to negotiate the liberalisation of trade in services, capital movements, public contracts, competition and intellectual property. The partnership agreement will contain a democracy clause and commits both parties to promote human rights and democratic values and support the rule of law. The committee believes that cooperation on human rights and democracy, which are designed to strengthen civil society and the rule of law, should begin as soon as the interim agreement is concluded.?

EC/Mexico agreement: interim agreement on trade, implementing economic partnership and cooperation agreement

OBJECTIVE: conclusion of an interim agreement on trade and trade-related matters between the Community and Mexico. COMMUNITY MEASURE: Council Decision 98/504/EC concerning the conclusion of the interim agreement on trade and trade-related matters between the European Community, of the one part, and the United Mexican States, of the other part. SUBSTANCE: The interim agreement aims to speed up implementation of the provisions on trade and trade-related matters of the Economic Partnership, Political Coordination and Cooperation Agreement signed in Brussels on 8 December 1997 between the Community and its Member States and Mexico (AVC97289). Numerous unilateral and bilateral declarations have been added to help interpret the agreement, in particular with regard to: - respect for the 'human rights' clause in the agreement, by Mexico, - application of European competition rules and certain international conventions on intellectual property, by the Community, - respect for certain international rules with regard to fisheries and maritime transport, by both parties. Early implementation of this agreement will enable both parties to begin negotiations with a view to implementing as soon as possible the liberalisation of trade which is the aim of the main agreement. A declaration annexed to the agreement describes the procedure which will lead to the conclusion of these negotiations and of the timetable for liberalisation of trade in goods and services which is linked to it. In the short term, the joint council and committee for managing the agreement and concluding the liberalisation negotiations will be established. ENTRY INTO FORCE: 1.07.1998 ?
