Potato starch quotas: 1998/1999, 1999/2000 and 2000/2001 marketing years

OBJECTIVE: allocation of the three-year quota between starch producer Member States for the 1998/99, 1999/2000 and 2000/01 marketing years, on the basis of the Commission's report to the Council on the quota system for potato starch, by amending, to this end, Regulation 1868/94/EC. SUBSTANCE: the proposal for a Regulation renews the existing quotas for three years, taking account of the definitive inclusion in the quota for Germany of the reserve of 104 554 tonnes referred to in the original Article 2(1) of Regulation 1868/94/EC. Where necessary, any amounts utilised in excess of quota by starch producers in the Member States under the flexibility clause during the 1997/98 marketing year will be taken into account. ?

Potato starch quotas: 1998/1999, 1999/2000 and 2000/2001 marketing years

The Committee adopted a report by Encarnación REDONDO JIMÉNEZ (EPP, E) on potato starch used in industry. This product currently receives subsidies which enable starch producers to buy it at a competitive price by comparison with other raw materials such as maize. There is an overall Community quota (1.5 million tonnes) for these subsidies, which have to be shared among the producer countries. The rapporteur asks why aid should be granted for potatoes grown for industrial purposes - chiefly in Germany, the Netherlands and northern France - and not for potatoes intended for consumption - which are produced throughout the Union. There is no market organisation for the latter and no subsidies are provided, despite a Commission proposal dating from 1992. The Committee endorses the rapporteur's argument and calls upon the Commission to introduce support for producers of potatoes intended for consumption. In addition, it accepts the idea of reducing the premium for potato-based starch, as it believes the industry already receives a level of aid which is unjustifiably high by comparison with that granted for cereal-based starch. ?

Potato starch quotas: 1998/1999, 1999/2000 and 2000/2001 marketing years

In adopting the report by Mrs Encarnación REDONDO JIM NEZ (PPE, E), the European Parliament calls on the Commission to introduce a number of measures to assist potato producers. For the 1998/1999, 1999/2000 and 2000/2001 it proposes that a premium be allocated to undertakings producing potato starch per tonne produced in respect of the quantity of potato starch covered by the quota referred to in Article 2(1) provided they have paid the potato producers the minimum price referred to in Article 8(1) of Regulation (EEC) 1766/92 in respect of the total quantity of potatoes needed to produce starch up to the ceiling laid down in the quota. ?

Potato starch quotas: 1998/1999, 1999/2000 and 2000/2001 marketing years

OBJECTIVE: To allocate the three-year quota for potato starch between the producer Member States for the years 1998/1999, 1999/2000 and 2000/2001. COMMUNITY MEASURE: Council Regulation (EC) 1284/98 amending regulation (EC) 1868/94 establishing a quota system for the production of potato starch. SUBSTANCE: Under the regulation, the following producer Member States are allocated the following maximum quotas for the production of potato starch for the 1998/1999, 1999/2000 and 2000/2001 marketing years: - Denmark: 178 460 tonnes - Germany: 696 271 tonnes - Spain: 2000 tonnes - France: 281 516 tonnes - Netherlands: 538 307 tonnes - Austria: 49 100 tonnes - Finland: 54 750 tonnes - Sweden: 63 900 tonnes - Total: 1 864 304 tonnes. ENTRY INTO FORCE: 24/06/1998. The regulation is applicable from 01/07/1998. ?
