Milk and milk products sector: additional levy (amend. regul. 3950/92/EEC)

OBJECTIVE: to extend by two twelve-month periods derogations to overcome the difficulties of restructuring holdings in Germany's new Länder. SUBSTANCE: with a view to definitively resolving the difficulties stemming from the restructuring of holdings in Germany's new Länder, the Commission proposes a final extension of the derogation by two twelve-month periods to 31/03/2000. The proposal will not have any financial impact on the Community budget. ?

Milk and milk products sector: additional levy (amend. regul. 3950/92/EEC)

The Commission unanimously adopted the draft legislative resolution on the approval of the Executive's proposal concerning the final extension, until 31 March 2000, of the derogation applicable to Germany's new Länder. The rapporteur, Mr Lutz Goepel (PPE, A) asked for the extension to be granted on the basis of the statement of reasons given by the Commission and the Council and, more importantly, stressed that the proposal would not have any financial impact on the budget given that no additional milk exempt from the additional levy would be supplied. ?

OBJECTIVE: to allow, exceptionally, a final extension for two twelve-month periods of the derogations to resolve the problems of restructuring dairy holdings on the territory of the former GDR. COMMUNITY MEASURE: Council Regulation 551/98/EC amendment Regulation (EEC) No 3950/92 establishing an additional levy in the milk and milk products sector. SUBSTANCE: with a view to the final resolution of the problems deriving from the restructuring of holdings in the new Länder, the regulation provides for a final extension of this derogation for two periods of twelve months until 31 March 2000. ENTRY INTO FORCE: 19/03/1998 ?
