## EP Rules of procedure: amendment after the signing of the Treaty of Amsterdam

This report deals the modifications to be made to the European Parliament's internal rules of procedure following the adoption of the Amsterdam Treaty. These modifications are examined in three main aspects: legislative procedure, procedures concerning the institutions in themselves or their co-operation in non-legislative fields, specific procedures concerning more specifically the Member States, the national parliaments and third countries.
