Fisheries and aquaculture sector: structural assistance, processing and marketing (codif. regul. 3699/93/EEC)

OBJECTIVE: consolidation of Regulation 3699/93/EC laying down the criteria and arrangements regarding Community structural assistance in the fisheries and aquaculture sector and the processing and marketing of its products. SUBSTANCE: this proposal aims to consolidate Regulation 3699/93/EC: the new regulation will supersede the various regulations incorporated in it; the content is fully preserved, and they are brought together with only such formal amendments as are required by the codification exercise itself. ?
