Energy: international cooperation, multiannual programme SYNERGY 1998-2002

OBJECTIVE: to establish a specific multiannual international cooperation programme in fields of mutual interest with third countries (SYNERGY), as part of the framework programme for energy 1998-2002 (CNS97302). SUBSTANCE: the Commission proposes continuing the SYNERGY programme, which concerns: - assistance in preparing, formulating and implementing the energy policies of third countries; - promotion of industrial cooperation between the Community and third countries in the field of energy; - stepping up the coordination of the Community's external action in the field of energy. The SYNERGY programme, for which the Commission proposes a budget of ECU 36.4 m for 1998-2002, will in particular support projects designed to: - improve energy efficiency in third countries; - promote the use of environmentally benign technology; - promote the exploitation of local resources, particularly renewable energy sources; - assist regional energy integration in third countries and the opening up of this sector; - promote dialogue on energy policy and contacts between Europe, third countries and particularly producing countries and international energy organizations; - support the penetration of European energy enterprises in third countries; - strengthen links between experts and decision-makers in the field of energy within the Community and between the Community and third countries. Community participation will not normally exceed 50% of the total cost of a project, and may be implemented on a co-financing basis with third countries, Member States or international organizations. The programme will also support the Union's external relations policy and help pave the way for the accession of Central and Eastern European countries.

Energy: international cooperation, multiannual programme SYNERGY 1998-2002

The Committee adopted the report in the field of multiannual energy programmes: all five are to do with the simplification and coordination of energy policy and is designed to establish priorities. The report by André SOULIER (EPP, F) was on the multiannual programme to promote international cooperation in the energy sector (SYNERGY). Mr Soulier felt that, in the light of the world and European energy outlook, it was now more necessary than ever to establish international cooperation in the field of energy policy. World energy reserves were still adequate, but they must be rationally managed. Helping non-Member countries to deal with the production and consumption of energy was the objective of energy cooperation as set up by the SYNERGY programme. Amendments were adopted on complementarity with other Community programmes, budgetary aspects and on the role of the EP. The programme, it was felt, should each year be allotted approximately 18% of the total amount earmarked for the Framework Programme for Energy.

In adopting the report by Mr André SOULIER (PPE, F), the European Parliament stressed the complementarity of the SYNERGY programme with other Community programmes, with a view to avoiding duplication of effort. It considered that the programme should receive around 18% of the total budget for the framework programme for energy each year.?

The Commission's amended proposal incorporates those of the European Parliament's amendments which underline the need for complementarity between the SYNERGY programme and other Community programmes, in order to avoid duplication.?

OBJECTIVE: to establish a specific multiannual international cooperation programme in fields of mutual interest with third countries (SYNERGY) as part of the 1998-2002 framework programme for energy. COMMUNITY MEASURE: Council Decision 1999/23/EC. CONTENTS: the Council decided to continue the SYNERGY programme, which concerns: - assistance to third countries in preparing, formulating and implementing the energy policies of third countries; - promotion of industrial cooperation between the Community and third countries in the field of energy; - stepping up the coordination of the Community's external actions in the field of energy. In order to achieve these objectives, the Community will help to support projects designed to: - provide advice and training in matters related to energy policy; - provide analysis and forecasts in energy matters; - promote dialogue in matters related to energy policy and the exchange of information (organisation of conferences and seminars); - support cross-border regional cooperation; - improve the framework for industrial cooperation in the field of energy. The reference amount for implementing the SYNERGY programme is ECU 15 m (of which ECU 6 m for the period 1998/1999).?
