## Transport sector: Euro-Mediterranean partnership

OBJECTIVE: to adopt a complete action plan for integration and greater cooperation in the field of transport in the Mediterranean.

SUBSTANCE: In its communication, the Commission presents the overall strategy it intends to implement in the field of transport in the Euro-Mediterranean region. The general aim is to integrate the transport network both between the Community and its Mediterranean partners and among the Mediterranean countries themselves. Taking as a basis the conclusions of the Barcelona Conference of November 1995 on the new Euro-Mediterranean Partnership, this strategy is designed ultimately to allow an area to be established within which people and goods will be able to move more easily. The strategy is to be two-pronged, comprising: 1) an infrastructure element, whereby the transport infrastructure networks of all the countries concerned are to be interconnected to create interoperable multimodal networks; 2) an efficient and cost-effective transport services element, these services to be provided in a common transport area in accordance with high environmental, social and safety standards. As part of this overall strategy, a complete action plan is laid down in the annex to the document. It summarizes all the measures taken and to be expanded, as well as future measures to be taken: -extension of trans-European networks: definition and planning of 'corridors' of international interest in the Mediterranean and development of the 'Corrimed' in the pan-European transport area of the Mediterranean; possible extension of corridors to the Eastern Mediterranean and Cyprus, -maritime transport and safety: a list of specific actions to be drawn up in these fields, -air transport and air traffic control: increasing air transport and air traffic control capacity consistently with the systems of third countries in the Mediterranean, -global satellite navigation system: extension of the GNSS system to the Mediterranean countries with a view to total interoperability, -rail transport and combined transport: development of combined transport axes and anticipation of vehicle technology needs, -transport research, -regional integration in the Mediterranean and Middle East: selection of multimodal transport corridors and definition of priority projects. The communication suggests setting up a working group including the Community's Mediterranean partners. It would be responsible for establishing contacts, exchanging information about transport projects of common interest and providing a more general picture of the ongoing activities at sub-regional level. The Commission intends to increase cooperation with the countries concerned and to facilitate the coordination of future projects under MEDA.?

## Transport sector: Euro-Mediterranean partnership

Rapporteur KAKLAMANIS welcomes the Commission communication concerning the Euro-Mediterranean Partnership in the Transport Sector, but emphasises that transport sector activities in this area must take account of typical subregional characteristics, the local and political context and be underpinned by a broad consensus among those most directly effected. He calls on the Commission to submit proposal for an action plan in the region, along the lines of the strategies already outlined at Community and pan-European level which in the future will provide for: - structured coordination between interministerial bodies already active at subregional level; - the inclusion of the region in a single transport infrastructure needs process; - the development and practical application of the results of research activities; - a documented timetable covering the initiatives to be undertaken and the objectives to be achieved by 2010 for passenger and freight transport in the Mediterranean region.?

## Transport sector: Euro-Mediterranean partnership

MEPs voted to endorse the resolution on the Commission's communication concerning the Euro-Mediterranean partnership in the transport sector. The Parliament's Rapporteur was Mr. Nikitas KAKLAMANIS (UPE, Greece). The Parliament demands the official and full participation of the European Parliament in the Euro-Mediterranean Forum for Transport, bringing together the 12 countries of the Mediterranean basin, the European Commission and the Council. It calls on the Commission to submit at the third ministerial conference, to be held in Stuttgart in April 1999, a proposal for an action plan for transport in the Mediterranean region, along the lines of the strategies already outlined at Community and pan-European level, which in the future will provide for : - structured co-ordination between inter-ministerial bodies already active at

sub-regional level, - the inclusion of the Mediterranean region in a single transport infrastructure needs assessment process (in line with the TINA model), - the development and practical application of the results of research activities (RETRAMED), - a documented timetable covering the initiatives to be undertaken and the objectives to be achieved by 2010 for passenger and freight transport in the Mediterranean region.?
