Agricultural prices 1998/1999: prices for white and raw sugar, A and B beet, compensation storage costs

Agricultural Prices 1998/99 - Sugar The Commission proposes a freeze on the basic price for beet, the intervention price for white sugar and the manufacturing margin. Consequently, the price proposals for sugar for 1998-99 are as follows: - basic price for beet: ECU 47.67/t - minimum price for A beet: ECU 46.77/t - minimum price for B beet: ECU 32.42/t - intervention price for white sugar: ECU 63.19/100 kg - target price for white sugar: ECU 66.50/100 kg - intervention price for raw sugar: ECU 52.37/100 kg. The minimum prices for A beet and B beet are maintained unchanged (they are derived from the basic price for beet by application of a levy of 2% and 30% respectively). However, it must be noted that the effective minimum price for B beet will depend ultimately on the final rate of the levy on B beet to be fixed later through the Management Committee procedure (in accordance with Article 28 of Regulation (EEC) No 1785/81). For Italy, the latest available statistics indicate that this Member State is not a deficit area and consequently no derived intervention price for white sugar is proposed. As far as the reimbursement of storage costs is concerned, the Commission proposes similarly that the amount of the monthly refund should be frozen at ECU 0.38 per 100 kg, in view of the stable interest rates prevailing in the Community.?

Agricultural prices 1998/1999: prices for white and raw sugar, A and B beet, compensation storage costs

In adopting the report by Mr Edouard des PLACES (I-EDN,F), the European Parliament tabled only few amendments to the Commission proposals concerning the prices of agricultural products (1998/1999). It calls for the creation of an adjustment coefficient for all CMOs in order to compensate for the possible disappearance of the green rate on 1 January 1999 for the Member States participating in the single currency.

Agricultural prices 1998/1999 - Sugar. COMMUNITY MEASURE: Council Regulation (EC) 1361/98 SUBSTANCE: the Council has decided to freeze the basic price for beet, the intervention price for white sugar and the manufacturing margin. Consequently, sugar prices for 1998/1999 are as follows: - basic price for beet: ECU 47.67 per tonne, - minimum price for A beet: ECU 46.72 per tonne, - minimum price for B beet: ECU 32.42 per tonne, - intervention price for white sugar: ECU 63.19 per 100 kg, - indicator price for white sugar: ECU 66.50 per 100 kg, - intervention price for raw sugar: ECU 52.37 per 100 kg. No derived intervention price has been set for white sugar for Italy. With regard to reimbursement of storage costs, the amount of monthly repayments has been frozen at ECU 0.38 per 100 kg of white sugar per month. ?
