Agricultural prices 1998/99 - Wine (Community vineyard register) The Commission proposes to extend to 31 December 2000 the deadline for the introduction of the simplified vineyard register in Greece and Portugal. This extension is necessary to account for the technical difficulties which have prevented its completion. ?

In adopting the report by Mr Edouard des PLACES (I-EDN,F) the European Parliament tabled only few amendments to the Commission proposals concerning the prices of agricultural products (1998- 1999). The European Parliament calls for the creation of an adjustment coefficient in order to compensate for the possible disappearance of the green rate on 1 January 1999 for the Member States participating in the single currency.?
