## Agricultural prices 1998/1999: beef and veal, common organisation of the market COM (amend. Regul. 805/68/EEC)

Agricultural Prices 1998/99 - Beef and veal (ceilings for premiums) Examination of the number of applications for the special premium in each Member State, the regional ceiling and the number of animals slaughtered has shown that Portugal and Spain have applications significantly in excess of their regional ceiling and the ratio between the ceiling and the number of animals slaughtered is lower than the average in the EU. In order to bring the regional ceilings closer to the actual level of production, it is proposed to increase the Portuguese and Spanish ceiling from 1 January 1997. In the 1996 November package, the ceiling for male animals qualifying for the special premium was reduced by 20% (in average) for the years 1997 and 1998, this means that in 1999 the old higher ceiling will again enter into force. It was also decided to authorize the Commission to take the necessary measures relating to the unused rights for suckler cows which revert to the national reserve during the same years 1997 and 1998. The Commission decided to freeze these unused rights. In order to maintain market balance until the adoption of the long-term reform in the context of Agenda 2000, it is proposed to extend these two measures by one year up to the end of 1999. ?

## Agricultural prices 1998/1999: beef and veal, common organisation of the market COM (amend. Regul. 805/68/EEC)

In adopting the report by Mr Edouard des PLACES (I-EDN, F) the European Parliament tabled only a few amendments to the Commission's proposals for the prices of agricultural products (1998-1999). The European Parliament called for an adjustment coefficient in order to compensate for the possible disappearance of the green rate on 1 January 1999 for the Member States participating in the single currency. Concerning beef and veal it calls for the maximum number of male bovine animals eligible for the special premium to be maintained in Spain

and Portugal, while the Commission proposes an increase. It also calls for the exemptions for the new German Länder concerning special premiums for male bovine animals to be maintained.?

Agricultural prices 1998/99 - Beef and veal (ceilings for premiums). COMMUNITY MEASURE: Council Regulation (EC) 1633/98, amending Regulation (EEC) 805/68. SUBSTANCE: The main points of the regulation are as follows: - the adjusted regional ceilings are maintained to the end of 1999; - the authorisation granted to the commission to take the necessary action on suckler cow premium rights unused in 1997 and 1998 is extended to the end of 1999; - a derogation is granted to the new German Länder for 1999. ?
