Agricultural prices 1998/1999: basic price and standard quality for pig carcasses

Agricultural Prices 1998/99 - Pigmeat In view of unchanged institutional grain prices, it is proposed to keep the basic price of pig carcasses unchanged and to fix it at ECU 1509.39 per tonne. The standard quality (unchanged) depends on weight and the amount of weight on the pig carcasse, as follows: - carcasses weighing 60 kg to less than 120 kg: grade E; - carcasses weighing 120 kg to 180 kg: grade R. ?

Agricultural prices 1998/1999: basic price and standard quality for pig carcasses

The Committee made only a few changes to the proposed agricultural prices for 1998-99 proposed by the Commission. MEPs did not adopt the amendments tabled by the rapporteur, Edouard DES PLACES (I-EN, F), for a general price increase of 1.7%. However, they did endorse his demand for the creation of an adjustment coefficient for all "common organisations of the market" (COMs) in order to compensate the Member States who will be joining the euro for the possible disappearance of the green ecu on 1st January 1999. As regards cereals, the main change proposed by the committee is: the provision for taking into interventions cereals with a maximum moisture content of 15% to be continued into the 1998-99 marketing year.?

Agricultural prices 1998/1999: basic price and standard quality for pig carcasses

In adopting the report by Mr Edouard des PLACES (I-EDN, F) the European Parliament tabled only a few amendments to the Commission's proposals for the prices of agricultural products (1998-1999). The European Parliament called for an adjustment coefficient in order to

compensate for the possible disappearance of the green rate on 1 January 1999 for the Member States participating in the single currency.?

Agricultural prices 1998/1999: basic price and standard quality for pig carcasses

Agricultural prices 1998/99 - Piguemeat. COMMUNITY MEASURE: Council Regulation (EEC) 1365/98. SUBSTANCE: The Council decided to maintain the basic price for slaughtered pigs of standard quality at its current level, ECU 1509.39/t. The standard quality (unchanged) is defined in terms of carcass weight and lean meet content, as follows: - Carcasses weighing 60 to less than 120 kg: grade E, - Carcasses weighing 120 to 180 kg: grade R. ?
