Part-time work, framework Agreement UNICE, CEEP and ETUC (exten. Directive 97/81/EC to the United Kingdom)

OBJECTIVE: to extend Council Directive 97/81/EC on the Framework Agreement on part-time work concluded by the two sides of industry to the United Kingdom. SUBSTANCE: Following the conclusion of the Amsterdam Treaty, which provides for the incorporation into the Treaty of the Protocol on Social Policy, and the decision by the United Kingdom to subscribe to the social provisions of the new Treaty, the Commission proposes extending Directive 97/81/EC on the Framework Agreement on part-time work concluded by UNICE, CEEP and the ETUC (see 'fiche de procédure' COS97221) to the UK. The extension of the Directive to the United Kingdom does not alter the text of the underlying Directive, except for one clause concerning the date of transposition of the Framework Agreement in the UK (2 years after the entry into force of the new Directive).?

Part-time work, framework Agreement UNICE, CEEP and ETUC (exten. Directive 97/81/EC to the United Kingdom)

Parliament approved the proposal for a directive seeking to extend to the United Kingdom Directive 97/81/EC on the framework agreement on part-time work (procedure without report) concluded by UNICE, CEEP and the ETUC. ?

Part-time work, framework Agreement UNICE, CEEP and ETUC (exten. Directive 97/81/EC to the United Kingdom)

OBJECTIVE: extension of Council Directive 97/81/EC on part-time work to the United Kingdom. COMMUNITY MEASURE: Council Directive 98/23/EC on the extension of Directive 97/81/EC on the framework agreement on part-time work concluded by UNICE, CEEP and the ETUC to the United Kingdom of Great Britain and Northern Ireland. SUBSTANCE: The Directive extends Directive 97/81/EC on the framework agreement on part-time work concluded by UNICE, CEEP and the ETUC to the United Kingdom (COS97221) which, because of the protocol on social policy, did not participate in this agreement. This extension does not alter the basic text of the directive, except for a provision on the date of transposition of the framework agreement in the United Kingdom, namely 7 April 2000. ENTRY INTO FORCE: the decision enters into force on 07.04.1998. DATE OF TRANSPOSITION IN THE UNITED KINGDOM: 07.04.2000. ?
