EEA Agreement: amending Annex I (Veterinary and phytosanitary matters)

OBJECTIVE: The draft decision of the EEA Joint Committee concerns amendment of Annex I to the EEA Agreement concerning veterinary and phytosanitary measures, with the aim of integrating recent Community legislation in this field. SUBSTANCE: In order to ensure the requisite legal security and homogeneity, the EEA Joint Committee is to integrate all the relevant Community legislation into the EEA Agreement as soon as possible after its adoption. The draft decision amends Annex I to the EEA Agreement, as last amended on 5 July 1996, in order to take account of new veterinary and phytosanitary provisions of relevance to the EEA (provisions concerning relations with third countries, border controls and animal welfare).?

The European Parliament adopted the report by Mrs Concepcio FERRER (PPE, E) concerning annex I (veterinary and phytosanitary matters) to the EEA agreement.?

PURPOSE : to amend Annex I of the EEA on questions on veterinary and phytosanitary matters with a view to adding the acquis communautaire which was recently adopted in this field. COMMUNITY MEASURE : Decision 69/98 of the EEA Joint Committee amending Annex I (Veterinary and Phytosanitary Matters) to the EEA Agreement. CONTENT : Decision 69/98 of the EEA Joint Committee aims to amend Annex I of the EEA Agreement on veterinary and phytosanitary matters, with the view to adding the acquis communautaire which was recently adopted in this field and last amended on 05.07.1996 (measures relating to relations with third world countries, border controls and animal welfare). In order to ensure the necessary legal security and homogeneity, the EEA Joint Committee must integrate all the relevant Community legislation in the EEA Agreement as soon as possible after its adoption. This is the purpose of this Decision. ENTRY INTO FORCE : the Decision will enter into force retroactively from 01.01.1998.?
