SAVE II, multiannual Community programme for energy efficiency: participation of Romania

OBJECTIVE: in the context of the pre-accession strategy, opening up the Community programme for energy efficiency (SAVE II) to Romania for the years 1998 to 2000. SUBSTANCE: This proposal for a decision by the EC-Romania Association Council establishes the terms and conditions for that country's participation in the SAVE II Community programme. In particular, Romania: - will participate in all the programme's activities on the same terms as the Member States and in conformity with the objectives, criteria and procedures of the programme; - will apply the same terms and conditions for the submission, assessment and selection of applications as those applying to the Member States; - will provide for a minimum number of partners from the Member States to be included in all proposed transnational actions and projects; - will pay a financial contribution to the Community budget to cover its participation in the programme.
