Motor vehicles, interiors fittings: electrical command of windows...(amend. direct. 74/60/EEC)

OBJECTIVE: the adoption of requirements with the aim of eliminating the danger to children of accidents which can occur when closing power-operated windows in private cars. SUBSTANCE: the Commission proposes to introduce in Directive 74/60/EEC requirements concerning power-operated windows, roof panel systems and partition systems for vehicles in the category M1 (passenger cars). It is proposed that these provisions will apply: - from 1 October 1999 for all new vehicle types; - from 1 October 2000 for all new vehicles. It is also proposed to align the administrative provisions of Directive 74/60/EEC with those of Directive 70/156/EEC concerning type-approval, so that type-approval can be computerized.?

The commission adopted the Commission proposal unamended. Rapporteur Sören WIBE (PES, S) noted that there were a number of minor errors in the original proposal but states that the Commission has given sufficient guarantees that they will be rectified. Thus he only lists them in the "B" part of the report, rather than submitting them as amendments for vote in Plenary.?

Under codecision procedure without debate, the European Parliament approved the proposal for a European Parliament and Council Directive amending Council Directive 74/60/EEC on the approximation of the laws of the Member States relating to the interior fittings of motor vehicles (interior parts of the passenger compartment other than the interior rear-view mirrors, layout of controls, the roof or opening roof, the backrest and rear part of the seats). The committee adopted the recommendation for second reading (codecision procedure) by Ana PALACIO VALLELERSUNDI (EPP/ED, E) approving the Council's common position. The committee noted that Parliament's observations at first reading concerning certain deficiencies in the drafting of the text had been duly taken into account in the common position and that the latter had made no changes of substance to the original Commission proposal. In view of the laudable aims of the directive and bearing in mind its highly technical nature, the committee endorsed the view taken by Parliament at first reading and recommended that the proposed act be adopted without amendment.

PURPOSE: to adopt requirements with the aim of eliminating the danger to children of accidents which can occur when closing power-operated windows in private cars. COMMUNITY MEASURE: Directive 2000/4/EEC of the European Parliament and of the Council amending Council Directive 74/60/EEC on the approximation of the laws of the Member States relating to the interior rear-view fittings of motor vehicles (interior parts of the passenger compartment other than the interior rear-view mirrors, layout of controls, the roof or sliding roof, the backrest and rear part of the seats). CONTENT: this Directive introduces requirements concerning power-operated windows, roof-panel systems and partition systems for vehicles in the category M1 (passengr cars). With effect from 08/04/2001, Member States may not, on grounds relating to the interior fittings of the motor vehicles, - refuse, in respect of a type of vehicle, to grant EC type- approval or national type-approval, or - prohibit the registration, sale or entry into service of vehicles; if the vehicles comply with the requirements of Directive 74/60/EEC. With effect from 08/04/2002, Member States shall no longer grant EC type-approval for a new type of vehicle on grounds relating to the interior fittings of the motor vehicles if the requirements of Directive 74/60/EEC are not complied with. With effect from 08/04/2003, Member States: - shall consider certificates of conformity which accompany new vehicles in accordance with the provisions of Directive 70/156/EEC to be no longer valid for the purposes of Article 7 (1) of that Directive, and - may refuse the registration, sale and entry into service of new vehicles which are not accompanied by a certificate of conformity unless Article 8(2) of Directive 70/156/EEC is invoked, on the

grounds relating to the interior fittings of motor vehicles if the vehicles are fitted with power-operated windows, roof panel and/or partition systems and the requirements of Directive 74/60/EEC, are not complied with. ENTRY INTO FORCE: 08/04/2001.?
