Community aid schemes, rice producers: integrated administration and control system (amend. regul. 3508/92/EEC)

OBJECTIVE: to amend Regulation (EC) No 3072/95 on the common organization of the market in rice so as to insert deadlines for lodging applications for compensation payments, and certain amendments to the latter. SUBSTANCE: in connection with the scheme for compensatory payments to rice producers, it is proposed that the date set by the Member State must not be later than 31 May preceding the harvest or, in the case of Portugal and Spain, later than 30 June preceding the harvest. ?

PURPOSE: to amend regulation 3508/92/EC establishing an integrated administration control system for certain Community aid schemes in order to specify the deadlines for lodging applications for compensatory payments and for certain amendments to applications in the producer Member States under the aid scheme for rice producers. COMMUNITY MEASURE: Council regulation 1036/1999/EC. CONTENT: In the context of compensatory payments to rice producers provided for in regulation 3508/92/EEC, the regulation specifies that the date fixed by the Member State may not be later than 31 May preceding the harvest in question and, in the case of Portugal and Spain, 30 June preceding the harvest. Certain amendments may be made to "area" aid applications provided the competent authorities receive these not later than those same respective dates. ENTRY INTO FORCE: 24/05/1999.?
