## Culture Community programmes: participation of the Czech republic in Raphaël

OBJECTIVE: in the framework of the pre-accession strategy, opening of the Community Raphael programme to the Czech Republic for the years 1998-2000. SUBSTANCE: this proposal for a decision of the EC-Czech Republic Association Council sets the conditions and arrangements for the participation of this country in the Community Raphael programme in the field of cultural heritage. In particular, the Czech Republic will: - participate in all actions derived from this programme under the same terms as the Member States and in accordance with the objectives, criteria and procedures laid down by these programmes; - apply the same conditions and arrangements for submission, assessment and selection of applications as those prevailing for the Member States; - ensure a minimum number of partners from the Member States for all the transnational actions and projects proposed; - make a financial contribution to the Community budget in relation to its participation in the programme. This financial contribution will cover financial support to Czech participants in the context of their participation in the Raphael programme and the supplementary costs of an administrative nature related to the management of the programmes by the Commission. The financial contribution will cover the participation of this country for the financial years 1998, 1999 and 2000. It will, however, be paid annually. The Community will pay part of this contribution by taking the sums needed from the annual funding for Phare/Czech Republic. The Phare contribution will not however cover the equivalent of the administrative sums relating to the management of the programmes by the Commission, which will remain entirely the responsibility of the Czech national budget. In total this financial contribution will amount to ECU 499 323 for the three years under consideration (of which ECU 240 000 under Phare). The Czech Republic will be associated with the monitoring of its participation in the Raphael cultural programme in preparation for the Community decision-making process on accession (in particular participation in the coordination meetings prior to the meetings of the programme committees and by being informed about the results). The participation of the Czech Republic will be valid for the duration of the programmes (i.e. until 31 December 2000). ?

## Culture Community programmes: participation of the Czech republic in Raphaël

The European Parliament adopted without debate the report by Mrs Odile LEPPERRE-VERRIER (ARE, F) on the participation of the Czech Republic in Community programmes in the field of culture. Parliament adopted a number of changes which sought to stress the fundamental role of culture in bringing peoples together and the positive effects of cultural activity on the economic and social development and democratic functioning of applicant countries. It also mentioned that cultural diversity in these countries needed to be respected, as did the minorities of which they are composed. It likewise considered that these countries should be permanently associated with the cultural programmes of the European Union irrespective of their transitional stage. Finally, from the point of view of the budget, it felt that the breakdown of appropriations to fund this action should appear in section III, part B of the European Union budget. It also insisted on greater transparency in debates concerning the various programme committees with which these countries should be more closely associated.?

## Culture Community programmes: participation of the Czech republic in Raphaël

OBJECTIVE: within the framework of the pre-accession strategy, to open up the Community's Raphael programme to the Czech Republic for the period 1998 to 2000. COMMUNITY MEASURE: Council Decision 98/656/EC adopting the conditions and procedures for the participation of the Czech Republic in the Community programme in the field of culture. SUBSTANCE: Decision 2/98 by the EC-Czech Republic Association Council lays down the conditions and procedures for the Czech Republic's participation in the Community programme in the field of cultural heritage. In particular, the Czech Republic: - shall participate in all actions of the programme under the same conditions as the Member States; - shall apply the same terms and conditions for the submission, assessment and selection of applications as those applying to the Member States; - shall include in all transnational measures and projects proposed a minimum number of partners from the Member States; - shall pay a contribution to the budget of the Community to cover its participation in the programme. This will cover the financial aid provided to Czech participants under the Raphael programme and the additional administrative costs imputable to the management of the programme by the Commission. It will cover the country's contribution for 1998, 1999 and 2000 and will be paid annually. To some extent, the Community will contribute to these contributions by deducting the necessary amounts from the annual financial allocation to PHARE/Czech Republic. However, PHARE would not cover the administrative costs imputable to the management of the programme by the Commission, which are to be met in their entirety from the Czech Republic's national budget. In total, this financial contribution amounts to ECU 499 323 for the three years concerned (of which ECU 240 000 comes under PHARE). The Czech Republic will be involved in monitoring its participation in the Raphael cultural programme in order to prepare for the Community decision-making process with a view to accession (particularly by attending coordination meetings before meetings of the programme's management committee and by being informed of the results of these meetings). ENTRY INTO FORCE: 1 December 1998. The Czech Republic's participation is valid for the duration of the programme (i.e. until 31 December 2000). ?
