Research RTD, 5th EC framework-programme 1998-2002: specific programme "quality of life and management of living resources"

OBJECTIVE: to adopt a specific programme for research, technological development and demonstration on 'Quality of life and management of living resources' (1998 to 2002). SUBSTANCE: with a view to the implementation of the fifth framework programme of R&TD, the Commission proposes adopting a specific programme on 'quality of life and management of living resources' for the period 1998-2002. The amount deemed necessary for the implementation of the specific programme is ECU 2635 m (ECU 547 m for 1998-1999; ECU 2088 m for 2000-2002). The main outlines of the programme are as follows: a) five key actions: - health, food and environmental factors, - control of infectious diseases, - the 'cell factory', - sustainable agriculture, fisheries and forestry, including integrated development of rural areas, - the ageing population; b) research and technological development activities of a generic nature: - chronic and degenerative diseases (e.g. cancer and diabetes), cardiovascular diseases and rare diseases; - research into genomes and diseases of genetic origin; - neurosciences; - public-health and health-services research; - biomedical ethics and bioethics; - socio-economic aspects of life sciences and technologies (impact on employment); c) support for research infrastructures. ?

## Research RTD, 5th EC framework-programme 1998-2002: specific programme "quality of life and management of living resources"

The Committee on Research, Technological Development and Energy has adopted the report TANNERT (PES,D) on the specific programme about "the quality of life" and implementing the 5th framework programme. The Committee took on board a Commission proposal for the distribution of the amount foreseen in two periods: one for 1999 (553) and another for 2000-2002 (1860). The EP and the Council could accept an overall amount for EC and Euratom research activities of Ecu 14.960 million, of which Ecu 13.700m for the EC programme and Ecu 1.260m for the Euratom programme.?

# Research RTD, 5th EC framework-programme 1998-2002: specific programme "quality of life and management of living resources"

Following on from the successful conclusion of the conciliation procedure between the Parliament and the Council of Ministers regarding the Fifth Framework Programme (1998-2002), the Parliament then adopted its opinion on the specific RTD programme on the 'quality of life and management of living resources', drafted by Mr. TANNERT (PSE, D). There were several amendments to the Commission's proposal adopted. Some of these relate to the budget: a total budget of 2413 million ECU was agreed. This is broken down into 553 million ECU for the 1998/99 period, and 1860 million ECU for the 2000/02 period. Other amendments were designed to take account of ethical, socio-economic, environmental, and health and safety considerations, as well as of sustainability and gender dimensions. The Parliament also introduced amendments to increase the involvement of SMEs, research centres and universities in the programme.?

COMMUNITY MEASURE: Council decision 1999/167/EC. CONTENT: in accordance with the 5th framework programme for R&D, the amount deemed necessary for carrying out the specific programme is EURO 2,413 million (EURO 553 million for the period 19998 to 1999 and EURO 1,860 million for the period 2000 to 2002).
