Decision 1999/168 OJ L 064 12.03.1999, p. 0020 Summary

Research RTD, 5th EC framework-programme 1998-2002: Specific programme "user-friendly information society"

OBJECTIVE: to adopt a specific programme for research, technological development and demonstration (1998 to 2002) on a 'User-friendly information society'. SUBSTANCE: with a view to the implementation of the fifth framework programme of R&TD, the Commission proposes adopting a specific programme on a 'user-friendly information society' for the period 1998-2002. The amount deemed necessary for the implementation of the specific programme is ECU 3925 m (ECU 853.4 m for 1998-1999; ECU 3071.6 m for 2000-2002). The main outlines of

the programme are as follows: a) four key actions: - systems and services for the citizen: health, persons with special needs (including the disabled and the elderly), administrations, environment, transport and tourism; - new methods of work and electronic commerce: flexible, mobile and remote working methods and tools; management systems for suppliers and consumers; information security; - multimedia content and tools: interactive electronic publishing and digital heritage and cultural content; education and training; human language technologies; information access, filtering, analysis and handling; - essential technologies and infrastructures: technologies for and the management of information processing, communications and networks; technologies and engineering for software, systems and services; real-time and large-scale simulation and visualisation techniques; mobile and personal communications and systems; peripherals; microelectronics; b) activities for generic research and development of technologies: future and emerging technologies; c) support for research infrastructures: research networking. ?

Research RTD, 5th EC framework-programme 1998-2002: Specific programme "user-friendly information society"

The Committee on Research, Technological Development and Energy has adopted the report of Mr. Malerba(EPP,I) on the specific programme about "the information society" and implementing the 5th framework programme. The Committee took on board a Commission proposal for the distribution of the amount foreseen in two periods: one for 1999 (857)and another for 2000-2002 (2743).The EP and the Council could accept an overall amount for EC and Euratom research activities of Ecu 14.960 million, of which Ecu 13.700m for the EC programme and Ecu 1.260m for the Euratom programme.?

Research RTD, 5th EC framework-programme 1998-2002: Specific programme "user-friendly information society"

Following on from the successful conclusion of the conciliation procedure between the Parliament and the Council, the Parliament then adopted its opinion drafted by Mr. MALERBA (I, PPE) concerning the specific RTD programme on the 'user friendly information society'. One of the main amendments adopted related to the budget for the programme : the overall budget will be 3600 million ECU, broken down into 857 million ECU for the 1998/99 period, and 2743 million ECU for the 2000/02 period. There were also some amendments relating to the participation of SMEs, as well as one designed to ensure that research funding does not go towards new 'eavesdropping' technology. A further amendment dealt with the protection of privacy and ethical considerations relating to the Internet.?

PURPOSE: to adopt a specific programme for research, technological development and demonstration on a user-friendly information society (1998-2002). COMMUNITY MEASURE: Council decision 1999/168/EC. CONTENT: in accordance with the 5th framework programme for RTD, the amount deemed necessary for carrying out the specific programme is EURO 3,600 million (EURO 857 million for the period 1998 to 1999 and EURO 2,743 million for the period 2000 to 2002). Indicative breakdown (in millions of Euros): a) key actions: - systems and services for the citizen: 646 - new methods of work and electronic commerce: 547 - multimedia content and tools: 564 - essential technologies and infrastructures: 1,363 b) research and technological development activities of a generic nature: future and emerging technologies: 319 c) support for research infrastructures (research networking): 161.?
