Decision 1999/169 OJ L 064 12.03.1999, p. 0040 Summary

Research RTD, 5th EC framework-programme 1998-2002: specific programme "competitive and sustainable growth"

OBJECTIVE: to adopt a specific programme for research, technological development and demonstration on 'Competitive and sustainable growth' (1998 to 2002). **SUBSTANCE:** with a view to the implementation of the fifth framework programme of R&TD, the Commission proposes adopting a specific programme on 'competitive and sustainable growth' for the period 1998-2002. The amount deemed necessary for the implementation of the specific programme is ECU 2895 m (ECU 640 m for 1998-1999; ECU 2255 m for 2000-2002). The main outlines of the programme are as follows: a) four key actions: - innovative products, processes and organisation: efficient design and manufacturing; intelligent production; eco-efficient processes; organisation of production and work; - sustainable mobility and intermodality: modal and intermodal transport management systems; infrastructures and their interfaces with transport means and systems; socio-economic scenarios for the mobility of people and goods; - land and marine transport technologies: innovative road and rail vehicle concepts: human-vehicle interaction; ships and offshore platforms; use of the sea and inland waterways to transport goods and passengers; rational management of the sea; - new perspectives for aeronautics: new-generation aircraft; operational efficiency and safety; b) research and technological development

activities of a generic nature: - new materials and their production and processing; - new materials and production technologies in the steel field; - measurements and testing (support for standardisation, combating fraud, improving quality); c) support for research infrastructures (setting up of virtual institutes, support for European metrological infrastructure, reference databases). ?

The Committee on Research, Technological Development and Energy has adopted the report of Mr. Argyros(EPP,Gr) on the specific programme about "the competitive growth" and implementing the 5th framework programme. The Committee took on board a Commission proposal for the distribution of the amount foreseen in two periods: one for 1999 (646)and another for 2000-2002 (2059).The EP and the Council could accept an overall amount for EC and Euratom research activities of Ecu 14.960 million, of which Ecu 13.700m for the EC programme and Ecu 1.260m for the Euratom programme.?

Following on from the successful conclusion of the conciliation procedure between then Fifth Framework Programme, the Parliament then adopted its opinion, drafted by Mr. ARGYROS (Gr, EPP) on the specific programme regarding RTD into 'sustainable and competitive growth' (1998-2002). The budget was amended to 2705 million ECU split into two sections : 646 million ECU for the period 1998/99 and 2059 million ECU for the period 2000/02. Several amendments designed to emphasise environmental and ecological considerations and the need for effective evaluation were also approved. A further concern of the Parliament was to encourage the presentation of projects that have a multiplier effect.?

PURPOSE: to adopt a specific programme for research, technological development and demonstration on competitive and sustainable growth (1998-2002). COMMUNITY MEASURE: Council decision 1999/169/EC. CONTENT: in accordance with the 5th framework programme for RTD, the amount deemed necessary for carrying out the specific programme is EURO 2705 million (EURO 646 million for the period 1998 to 1999 and EURO 2,059 million for the period 2000 to 2002). Indicative breakdown (in millions of Euros): a) key actions: - innovative products, processes and organisation: 731 - sustainable mobility and intermodality: 371 - land transport and marine technologies: 320 - new perspectives for aeronautics: 700 b) research and technological development activities of a generic nature (new materials, measurements and testing): 546 c) support for research infrastructures: 37.?
