## Research RTD, 5th EC framework-programme 1998-2002: specific programme "international role of Community research"

OBJECTIVE: to adopt a specific programme for research, technological development and demonstration on 'Confirming the international role of Community research' (1998 to 2002). SUBSTANCE: with a view to the implementation of the fifth framework programme of R&TD, the

Commission proposes adopting a specific programme on 'confirming the international role of Community research' for the period 1998-2002. The amount deemed necessary for the implementation of the specific programme is ECU 491 m (ECU 70 m for 1998-1999; ECU 421 m for 2000-2002). The strategic objectives of the programme are as follows: - to promote scientific and technological cooperation between undertakings, organisations and researchers from third countries and from the Community; - to facilitate access for research centres and undertakings established in the Community to scientific and technological knowledge available outside the Community and useful to the Community's interests; - to enhance the position and role of Community research in the international scientific and technological arena and to promote a European scientific and technological culture; - to prepare for the accession of new Member States (to contribute to the stabilisation of the RTD potential of the countries of Central and Eastern Europe and the Newly Independent States of the former Soviet Union; to support the Euro-Mediterranean partnership; to contribute to the scientific development of developing countries); - to help European research players acquire information and gain experience of research capacity, activity and priorities of industrialised third countries and 'emerging economy' countries. ?

The Committee on Research, Technological Development and Energy has adopted the report of Mr. MARSET CAMPOS (EPP,E) on the specific programme about "the international cooperation" and implementing the 5th framework programme. The Committee took on board a Commission proposal for the distribution of the amount foreseen in two periods: one for 1999 (78) and another for 2000-2002 (397). The EP and the Council could accept an overall amount for EC and Euratom research activities of Ecu 14.960 million, of which Ecu 13.700m for the EC programme and Ecu 1.260m for the Euratom programme.?

Following on from the successful conclusion of the conciliation procedure between the Parliament and the Council of Ministers regarding the Fifth Framework Programme, the Parliament adopted its opinion on the specific RTD programme entitled 'confirming the international role of Community research' (1998-2002), drafted by Mr. MARSET CAMPOS (E, EUL/NGL). The overall budget for the programme was reduced to 475 million ECU. 78 million ECU are to be available in 1998/99, and 397 million in the period 2000/02. Most of the other amendments adopted related to the geographic allocation of funds and EU participation in international programmes and the dissemination of results.?

PURPOSE: to adopt a specific programme on confirming the international role of Community research (1998 to 2002). COMMUNITY MEASURE: Council decision 1999/171/EC. CONTENT: in accordance with the 5th framework programme for RTD, the amount deemed necessary for carrying out the specific programme is EURO 475 million (EURO 78 Million for the period 1998 to 1999 and EURO 397 million for the period 2000 to 2002). Indicative breakdown (in millions of Euros): a) cooperation with third countries: - pre-accession States: 26 - NIS and other CEECs: 112 - Mediterranean partners: 55 - developing countries: 210 - emerging economy countries and industrialised countries: 5 b) training of researchers: 15 c) coordination: 52.?
