EEA Agreement: amending Annex XIII (transport)

OBJECTIVE: the draft decision by the EEA Joint Committee concerns the amendment of Annex XIII to the EEA Agreement relating to transport, with the aim of integrating the Community acquis recently adopted in this field. SUBSTANCE: in order to ensure the requisite legal security and homogeneity, the EEA Joint Committee is to integrate all the relevant Community legislation into the EEA Agreement as soon as possible after its adoption. The draft decision is intended to amend Annex XIII to the EEA Agreement to take account of the Community acquis in the field of transport (Directive 97/44/EC concerning summer time). Iceland has requested a derogation from the Directive because of its specific geographical location. Accordingly, it will apply summer time all the year round.?

PURPOSE : to amend annex XIII (Transport) to the EEA Agreement with the view to adding the acquis communautaire recently adopted in this field. COMMUNITY MEASURE : Decision of the EEA Committee No 11/1999 amending Annex XIII (Transport) to the EEA Agreement. CONTENT : the Decision amends Annex XIII of the EEA Agreement in order to include the Directive 97/44/EC relating to summertime arrangements. Furthermore, due to its geographical situation, Iceland shall apply Greenwich Mean Time (GMT) throughout the year. ENRTY INTO FORCE : 30.01.1999.?
