Honey: measures to improve the production and marketing

OBJECTIVE: to extend the time limit laid down by Regulation (EC) No 1221/97 laying down general rules for the application of measures to improve the production and marketing of honey. SUBSTANCE: due to the time limit laid down by Regulation (EC) No 1221/97 for the first year, the national programmes for the improvement of honey production and marketing applied only from 12/03/1998. On the other hand, that Regulation provided for a deadline of 15 October each year by which expenditures must be made. In order to avoid too big a reduction in the national programme period in the first year, it is proposed that the deadline for payments be extended to 31/01/1999. ?

Honey: measures to improve the production and marketing

The European Parliament approved the proposal (procedure without report). It asked the Commission to submit an interim report to the European Parliament and to the Council by 31 December 1999 on the implementation of national programmes during the first year of application and on payments made up to that date.?

OBJECTIVE: to postpone the time limit laid down by Regulation (EC) 1221/97 laying down general rules for the application of measures to improve the production and marketing of honey. COMMUNITY MEASURE: Council Regulation (EC) 2070/98. SUBSTANCE: The regulation states that expenditure on the measures taken under the annual national programmes must be made by the Member States by 15 October each year. However, in order to avoid too great a shortening of the national programmes in the first year, the time limit for making payments has been postponed to 31 January 1999. ENTRY INTO FORCE: 30/9/1998. ?
