Ariane: support programme in the field of books and reading, including translation until 31 December 1999

OBJECTIVE: to extend the Ariane programme by one year to 31 December 1999. CONTENT: pending adoption of the European Community framework programme for culture for the period 2000-2004 (COD98169), which is to include all existing measures in the field of culture (including the Ariane support programme in the field of books and reading), the current Ariane programme needs to be extended by one year (from 31 December 1998 to 31 December 1999) under the same conditions as those laid down in Decision 2085/97/EC establishing the programme (COD94189) in order to ensure continuity of Community support for cultural projects in this field. From a budgetary point of view, extending the Ariane programme will imply an increase in the financial package initially provided for the programme: it is proposed to increase the financial package to EUR 10 million for the entire duration of the programme (by allocating the sum of EUR 3 million to Ariane for 1999). This amount will need to be adjusted on the basis of the final amount allocated to the programme in the 1999 budget.?

Ariane: support programme in the field of books and reading, including translation until 31 December 1999

The Committee adopted the report by Mr Pex on extending the Ariane programme to 1999, pending adoption of the framework programme for culture (2000-2004) which is to include all existing measures in the field of culture. The committee proposed, through the amendment tabled by its chair and rapporteur, that funding for Ariane be increased by ECU 1.1 million over the Commission proposal (4.1 million instead of 3 million), so that overall funding for the new period of the programme (1997-99) would be ECU 11.1 million.?

Ariane: support programme in the field of books and reading, including translation until 31 December 1999

In adopting the report by Mr Peter PEX (PPE, NL) on a one-year extension to the Ariane programme on books and reading, Parliament called for the budget for 1999 to be increased from the EUR 3 m proposed by the Commission to EUR 4.1, thus increasing the total Ariane budget from EUR 10 m to 11.1 m.?

In its amended proposal, the Commission incorporated the sole amendment adopted by Parliament, and accordingly increased the overall financial package for the Ariane programme from EUR 10 m to EUR 11.1 m.?

In its common position on the extension of the Ariane programme, the Council fully endorsed Parliament's position, which called for an increase in the overall financial package for the programme. As a result, it was now proposed that Ariane's budget for 1999 should be EUR 4.1 m (as against EUR 3 m, as originally proposed). The overall financial package was increased to EUR 11.1 m.?

In its opinion on the common position concerning the Ariane programme, the Commission fully endorsed the Council's text, which incorporated the only amendment adopted by Parliament at first reading.?

The European Parliament adopted without debate the recommendation for second reading by Mr. Peter PEX (EPP, NL), approving the Council's common position on the Ariane programme.?

Ariane: support programme in the field of books and reading, including translation until 31 December 1999

PURPOSE: to extend the duration of the Ariane programme by one year until 31/12/1999. COMMUNITY MEASURE: decision 476/1999/EC of

the European Parliament and of the Council amending decision 2085/97/EC establishing a programme of support including translation, in the field of books and reading (Ariane). CONTENT: Pending the adoption of the European Community's framework programme "Culture" for the period 2000-2004, which incorporates all actions currently in force in the cultural field (including the support action of Ariane to books and reading), this decision extends by one year the current Ariane programme (from 31/12/1998 until 31/12/1999) according to the same conditions as those provided for by decision 2085/97/EC which established the programme. The extension of Ariane will mean an increase in the budget initially proposed for the programme. The new financial allocation will therefore amount to a total of EURO 11.1 million for the duration of the programme (allocating an additional amount of EURO 4.1 million for 1999). ENTRY INTO FORCE: 01/01/1999.?
