Decision 1999/477 OJ L 057 05.03.1999, p. 0002 Summary

Kaleidoscope: programme to support artistic and cultural activities until 31 December 1999

OBJECTIVE: to extend the Kaleidoscope programme by one year to 31 December 1999. CONTENT: pending adoption of the European Community framework programme for culture for the period 2000-2004 (COD98169), which is to include all existing measures in the field of culture (including the Kaleidoscope programme to support artistic and cultural activities with a European dimension), the current Kaleidoscope programme needs to be extended by one year (from 31 December 1998 to 31 December 1999) under the same conditions as those laid down in Decision 719/96/EC establishing the programme (COD94188) in order to ensure continuity of Community support for cultural programmes. From a budgetary point of view, extending the Kaleidoscope programme will imply an increase in the financial package initially provided for the programme: it is proposed to increase the financial package to EUR 34.4 million for the entire duration of the programme (by allocating the sum of EUR 7.9 million to Kaleidoscope for 1999). This amount will need to be adjusted on the basis of the final amount allocated to the programme in the 1999 budget.?

Kaleidoscope: programme to support artistic and cultural activities until 31 December 1999

The Committee adopted the report by Mr Pex on extending Kaleidoscope programme to 1999, pending adoption of the framework programme for culture (2000-2004) which is to include all existing measures in the field of culture. The amendment to the Kaleidoscope programme proposes an increase of ECU 2.3 million (10.2 million instead of the 7.9 million proposed by the Commission), making the overall amount for the new period (1996-99) for this programme ECU 36.7 million.?

Kaleidoscope: programme to support artistic and cultural activities until 31 December 1999

In adopting the report by Mr Peter PEX (PPE, NL) on a one-year extension to the Kaleidoscope programme on artistic and cultural activities, Parliament called for the budget for 1999 to be increased from the EUR 7.9 m proposed by the Commission to EUR 10.2, thus increasing the total Kaleidoscope budget from EUR 34.4 m to 36.7 m.?

In its amended proposal, the Commission incorporated the sole amendment adopted by Parliament, and accordingly increased the overall financial package for the Kaleidoscope programme from EUR 34.4 m to EUR 36.7 m.?

Kaleidoscope: programme to support artistic and cultural activities until 31 December 1999

In its common position on the extension of the Kaleidoscope programme, the Council fully endorsed Parliament's position, which called for an increase in the overall financial package for the programme. As a result, it was now proposed that Kaleidoscope's budget for 1999 should be EUR 10.2 m (as against EUR 7.9 m, as originally proposed). The overall financial package was increased to EUR 36.7 m.?

In its opinion on the common position concerning the Kaleidoscope programme, the Commission fully endorsed the Council's text, which incorporated the only amendment adopted by Parliament at first reading.?

Kaleidoscope: programme to support artistic and cultural activities until 31 December 1999

The European Parliament adopted without debate the recommendation for second reading by Mr. Peter PEX (EPP, NL) approving the Council's common position on the Kaleidoscope programme.?

Kaleidoscope: programme to support artistic and cultural activities until 31 December 1999

PURPOSE: to extend the duration of the Kaleidoscope programme by one year until 31/12/1999. COMMUNITY MEASURE: decision 477/1999/EC of the European Parliament and of the Council amending decision 719/96/EC establishing a programme to support artistic and cultural activities having a European dimension (Kaleidoscope). CONTENT: Pending the adoption of the European Community's framework programme "Culture" for the period 2000-2004, which incorporates all actions currently in force in the cultural field (including the Kaleidoscope programme), this decision extends by one year the current Kaleidoscope programme (from 31/12/1998 until 31/12/1999) according to the same conditions as those provided for by decision 719/96/EC which established the programme. The extension of Kaleidoscope will mean an increase in the budget initially proposed for the programme. The new financial allocation will therefore amount to a total of EURO 36.7 million for the duration of the programme (allocating an additional amount of EURO 10.2 million for 1999). ENTRY INTO FORCE: 01/01/1999.?
