Animal nutrition: official inspections

OBJECTIVE: to amend Directive 95/53/EC to provide a legal instrument better suited to inspection needs in the field of animal nutrition. SUBSTANCE: the proposed amendments would enable the Commission to adopt additional measures in order to establish a reliable, harmonised procedure for documentary, identity and physical checks for all products from third countries used in animal nutrition. To this end, the proposal seeks to: - permit experts from the Commission and Member States to carry out on-the-spot checks not only in the Community but also in third countries, particularly if a phenomenon arises which may adversely affect the healthiness of animal feed placed in circulation in the Community; - adopt a safeguard system and enable the Commission to send Community experts to carry out on-the-spot checks if

necessary to ascertain whether Community rules are being respected and, if appropriate, to adopt suitable measures to deal with the situation; - entrust to the Commission the task of adopting specific coordinated inspection programmes in addition to the general programmes already provided for by Directive 95/53/EC in the event of unexpected contamination which could present a serious and imminent danger to human and animal health.?

Animal nutrition: official inspections

The European Parliament confirmed the first reading in the context of the codecision procedure of the text that it adopted on 16.12.1998 concerning this proposal for a directive.?

Animal nutrition: official inspections

The Council's common position approved the substance of the Commission's proposal by making some amendments to which the Commission can agree upon. These amendments concern, in particular, the proposal's choice of legal basis (Article 152, paragraph 4 of the EC Treaty instead of Article 100 A), as well as the introduction of the obligation to examine the outcome of the inspections made shall be discussed with the competent authorities before a final report is drawn up and circulated. The Council, furthermore, has introduced an important amendment aiming to amend the first Article, point 4, of the Commission's initial proposal and to add the first Article, point 8, to the proposed amendments. Originally, this provision allowed the Commission, in cases of emergency posing serious risk to human health or animal health or the environment, to take immediate protective measures against products imported from the third countries, without previously consulting the Member States. The Council has decided that the Commission on its own initiative or at the request of a Member State, shall immediately take the necessary measures. The Council introduced a new Article "23a" stipulating the procedure to take a safeguard measure based on Article 5 of Decision 99/468/EC on comitology.?

Animal nutrition: official inspections

One of the most problematic issues for achieving a common position has been the legal basis (100A) of the proposal. With the entry into force of the Treaty of Amsterdam, the Council and the Commission agreed that the proposal should be based on Article 152 (4). The Commission was also able to agree with editorial and minor formulation changes to the Commission proposal because these improve its clarity. On the other hand, the Commission cannot agree with the regulatory procedure chosen by the Council to take emergency protective measures against imports from third countries. Unlike the safeguard procedures as proposed by the Commission, this would not provide the means for rapid action when so required by an emergency situation. The Commission made a written unilateral statement for the minutes of the Council meeting at which the common position was adopted, in which it underlined that it maintained its proposal for a safeguard procedure, in line with the comitology decision (Decision 1999/468/EEC) since only this procedure would ensure that a prompt decision can be taken in each and every case.?

Animal nutrition: official inspections

The committee adopted the recommendation for second reading (codecision procedure) by Bart STAES (Greens/EFA, B) amending the Council common position on the principles governing the organisation of official inspections in the field of animal nutrition. The committee stood up for the Commission's right to carry out spot checks on animal feed in the Member States, saying that experts must be allowed to carry out checks without warning as soon as the health of animal feed on the Community market was at risk. The problem with the common position, in the committee's view, was the administrative method chosen: the Council had opted for a "regulatory committee" procedure instead of a "safeguard" procedure, which meant the Commission would not be able to take rapid action even in an emergency. Under the Commission's original proposal, it would have retained the power, in emergencies, to take safeguard measures appropriate in the case of animal feed, but this suggestion was deleted in the common position. The committee, however, unanimously backed its rapporteur in calling for this point to be reinstated.?

Animal nutrition: official inspections

In adopting the report by Mr. Bart Staes (Green/EFA, B), the European Parliament approves the legislative resolution on the common position of the Council with a view to the adoption of a European Parliament and Council Directive amending Directive 95/53/EEC fixing the principles governing the organisation of official inspections in the field of animal nutrition. The report was subject to some amendments which relate to the following issues: - the Commission consulting the Member States, except in emergencies, before taking measures such as suspending imports from all or part of the third country concerned or from one or more specific production establishments and, where appropriate, any third country of transit and/or lay down special conditions for products intended for import from all or part of the third country concerned; - the Commission may decide to carry out unannounced inspections in the Member States and they shall subsequently inform the Member States and the European Parliament of the results of inspections carried out and circulate an inspection report.?

Animal nutrition: official inspections

The Commission is in favour of all the amendments to the common position, voted by the European Parliament although it emphasises that the most important amendments are those affecting the procedure to adopt a safeguard measure. Conversely, the amendment relating to on-the-spot inspections is not essential to improved inspections in the field of animal nutrition.?

Animal nutrition: official inspections

The Conciliation Committee reached agreement on a joint text for the directive. The compromise reached involved two main issues: (a) safeguard measures - the Commission may take safeguard measures in emergency situations without consulting Member States. The measures will apply immediately and will have to be submitted within 10 days to the appropriate committee which may then extend, amend or repeal them. This safeguard clause is based on similar provisions in the 1997 directive on veterinary checks on imports. Parliament also insisted on a clarification in the text to guarantee that the safeguard measures would remain in force until they were replaced by another act (e.g. a new decision of the Standing Committee); (b) inspections - in an effort to find a global compromise, Parliament withdrew its call for unannounced inspections in the Member States but insisted on a high level of assistance to be provided by the Member States to the Commission regarding inspections. Council agreed to Parliament's request that the Member States should provide "full assistance" rather than "all necessary assistance" to the Commission officials carrying out on-the-spot inspections. It was also agreed that Parliament should be informed about the results of inspections carried out. Parliament's delegation felt that the compromise reached would mean that the directive helped to increase safety in this sensitive area and provide the Commission with the possibility of adopting effective and rapid safeguard measures in emergency situations. It therefore recommended that Parliament adopt the joint text at third reading.?

Animal nutrition: official inspections

The European Parliament approved the text by Mr Bart STAES (Greens/EFA, B) on the agreement reached in the Conciliation Committee. It covers the rules relating to on-the-spot checks and animal inspections with a view to ensuring respect for high health standards. The compromise reached provides for the Commission to take unilateral safeguard measures in the event of an emergency with the Member States agreeing to provide 'full assistance' to all EU inspectors, who will be obliged to give advance notice of any planned visit. ?

Animal nutrition: official inspections

PURPOSE: to present a legal instrument better adapted to the needs of inspections in the field of animal nutrition. COMMUNITY MEASURE: Directive 2000/77/EC of the European Parliament and of the Council amending Council Directive 93/53/EC fixing the principles governing the organisation of official inspections in the field of animal nutrition. CONTENT: the Directive seeks to adequately protect human and animal health and the environment, through the ability of experts to carry out on-the-spot inspections not only in the Community but also in third countries, in particular following the appearance in a third country of any problem likely to affect the health of animal feedingstuffs put into circulation in the Community. Moreover, the Commission has the possibility of, where necessary, sending experts to carry out on-the-spot inspections in the Community to check that Community rules are being applied and, where appropriate, adopting Community measures. Lastly, the Directive introduces a system of protective measures. ENTRY INTO FORCE: 29/12/2001.?
