Fishing resources, conservation of Atlantic Tunas ICCAT 1997: transhipments and vessel observation

PURPOSE : Proposal for a Council Regulation laying down certain control measures to ensure compliance with the measures adopted by ICCAT. CONTENT: The European Community became a contracting party to the International Convention for the Conservation of Atlantic Tunas (ICCAT) in 1997. Its purpose is the conservation and management of resources of tuna and tuna-like fish in the Atlantic and adjacent seas. ICCAT has adopted conservation and management measures that are binding on contracting parties. Fishing by certain vessels that is contrary to these measures is threatening their effectiveness. To discourage illegal activity, ICCAT meeting in November 1997, adopted a recommendation on trans-shipments and vessel observation. In the absence of any objection, this recommendation became binding on the contracting parties from 13 June 1998. As a contracting party, the Community should apply it, and the purpose of the proposal is to incorporate it into Community law. The Regulation will restrict shipments to Community vessels at sea of species falling within the competence of ICCAT to fish from vessels flying the flag of a co-operating party, entity or fishing entity. It will also set requirements on exchange of information on vessels suspected of activity detrimental to the effectiveness of the conservation and management measures adopted by ICCAT. These provisions will help improve monitoring at sea and discourage illegal fishing.?

Fishing resources, conservation of Atlantic Tunas ICCAT 1997: transhipments and vessel observation

The Committee has adopted the report by Dominique Souchet (I-EN, F) on the introduction of monitoring measures to enforce measures adopted by the International Convention for the Conservation of Atlantic Tuna (ICCAT). The aim of the ICCAT is to ensure the conservation and management of tuna and similar species in the Atlantic and neighbouring seas. Conservation and management measures adopted by the ICCAT are binding on all contracting parties. Any vessel fishing in a manner which conflicts with the ICCAT's conservation measures compromises the effectiveness of these measures and creates an unfair situation in relation to the vessels which do observe them.?

PURPOSE : to establish new control measures for fishing in the sea to ensure compliance with the measures which were recently adopted by the ICCAT and to discourage illegal fishing. COMMUNITY MEASURE : Council Regulation 1351/1999/EC laying down certain control measures to ensure compliance with the measures adopted by ICCAT. CONTENT : the International Convention for the Conservation of Atlantic Tuna (ICCAT), to which the Community is a party, has as its objective to ensure the conservation and the management of resources of tuna and tuna-like fish in the Atlantic Ocean and adjacent seas, and the adoption of recommendations on conservation and management in the Convention area that become binding on contracting parties. There is an ICCAT recommendation from 1997 on trans-shipments and vessel observation that seeks to discourage the exercise of illegal fishing and this became obligatory for the parties on 13.06.1998. The Community must apply this recommendation through this Regulation, which provides that Community fishing vessels: - limit the trans-shipments at sea from ships flying the flag of contracting party of the ICCAT or parties said to be "cooperating" (which are non-contracting but who observe certain ICCAT recommendations), - make provision with regard to the exchange of information on the activities of vessels likely to jeopardise the efficiency of conservation and management measures adopted by the ICCAT. The Regulation also seeks to encourage the non-contracting parties of the ICCAT to accede to the status of 'cooperating parties' by accepting to agree to respecting the measures adopted by this Regulation so as not to jeopardise the effects of the measures already taken.
