Basel Convention, annexes I, VIII, IX: hazardous wastes, transboundary movements and disposal

PURPOSE : Proposal for a Council Decision on the approval, on behalf of the Community, of the amendment of Annex I and the adoption of new Annexes VIII and IX to the Convention on the control of trans-boundary movements of hazardous wastes and their disposal (Basel Convention), as laid down in Decision IV/9 of the Conference of the Parties. CONTENT: In February 1998, Decision IV/9 was adopted by consensus by the Fourth Conference of the Parties to the Basel Convention. Its Annex VIII is a list of wastes that the Convention's Technical Working Groups characterised as hazardous and its Annex IX is a list of wastes that the Technical Working Group characterised as not covered by its definition. Decision IV/9 also amended Annex I, adding to it a number of explanatory notes in relation to Annexes VIII and IX. The amended and additional Annexes to the Convention will come into force for all Parties to the Convention which have not notified the Depository that they are unable to accept an Annex, six months after the date of communication of the adoption of the Annexes by the Depository, in accordance with Article 18, paragraph 2, c) of the Convention.?

Basel Convention, annexes I, VIII, IX: hazardous wastes, transboundary movements and disposal

The Basle Convention of 1989 calls for a prohibition on the export of waste from industrialised to developing countries. The signatory states thought it necessary because more and more toxic waste was being exported to third world countries under the guise of "raw material" or "for recycling". The Committee agreed on March 16 to approve the amendment of Annexes I, VIII and IX of the Convention to clarify differences between hazardous and non-hazardous waste. However, rapporteur Marilies FLEMMING (EPP,A) referred to inconsistencies between the classification in the Basle Convention and that used in the European inventory of hazardous wastes. She also pointed out that the prohibition on the export of waste had not yet come into force because not enough signatories had ratified the Basle Convention. She asked the Commission to enable countries to ratify by making information and technical assistance available. ?

Basel Convention, annexes I, VIII, IX: hazardous wastes, transboundary movements and disposal

Under consultation procedure, the European Parliament adopted the legislative resolution by Marialiese Flemming (PPE,AT), which approves the Commission proposal for a Council decision on the approval, on behalf of the Community, of the amendment of Annex I and the adoption of new Annexes VIII and IX to the Convention on the control of transboundary movements of hazardous wastes and other disposal (Basel Convention), as laid down in Decision IV/9 of the Conference of the Parties.?
