Agricultural prices 1999/2000: intervention price for cereals, monthly increases (regul. 1766/92/EEC and 923/96/EC)

Prices for agricultural products 1999/2000 - Cereals: 1) Cereals prices: the arrangements introduced by the reform of the arable crops sector have been fully in place since 01/07/95. In this connection, it should be remembered that the intervention price for all cereals was set at EUR 119.19/tonne. Furthermore, under the Agenda 2000 proposals, the Commission proposed that the price be reduced by 20% as from the 2000/2001 harvest, to EUR 95.35/tonne for all cereals. 2) Monthly increments: as the interest rates have come back down to 3%, it is proposed that the monthly increase should be kept at EUR 1.0/month for the 1999/2000 marketing year. Under the Agenda 2000 proposals, the monthly increase will lapse as from 2000/2001.?

Under consultation procedure, the European Parliament approved the Commission proposal for a Council Regulation fixing the monthly increases in the intervention price for cereals for the 1999/2000 marketing year.?

Agricultural prices 1999/2000: intervention price for cereals, monthly increases (regul. 1766/92/EEC and 923/96/EC)

PURPOSE: Agricultural prices 1999/2000 - cereals (monthly increases). COMMUNITY MEASURE: Council Regulation 1671/1999/EC fixing the monthly increases in the intervention price for cereals for the 1999/2000 marketing year. CONTENT: The Council has decided to keep at 1.0 euro per tonne the level of the monthly increase for the 1999/2000 marketing year. It should be noted that the single intervention price for

all cereals has already been fixed at 119.19 euros per tonne. ENTRY INTO FORCE: 30.07.1999. The Regulation shall apply with effect from the 1999/2000 marketing year.?
