EC/Cyprus relations: financial and technical cooperation, 4th protocol, extension

PURPOSE : extend until 31.12.1999 the period during which the funds available in the context of the IVth EC-Cyprus Protocol can be committed. **CONTENT** : the period during which the funds available under the financial protocol that currently exists between the Community and Cyprus expires on 31.12.1998. It is clear that it will not be possible to commit all the funds (74 MEUR) before that date. The purpose of this proposal is to extend until 31.12.1999 the period in question in order to permit the Community to fulfill its financial commitments and thus to contribute to closer relations between the island and the Community.?

Under assent procedure without report, the European Parliament gave its assent to the proposal for a Council decision concerning the conclusion of a protocol on the extension of the period during which the funds laid down in the 4th protocol on financial and technical cooperation between the European Community and the Republic of Cyprus may be committed.?

EC/Cyprus relations: financial and technical cooperation, 4th protocol, extension

PURPOSE: to extend until 31/12/1999 the period during which the funds laid down in the Fourth Protocol on financial and technical cooperation between the European Community and the Republic of Cyprus may be committed. **COMMUNITY MEASURE**: Council decision 1999/258/EC. **CONTENT**: the period during which the funds available under the financial protocol between the Community and Cyprus can currently be committed until 31/12/1998. These funds (EURO 74 million) could not be committed before this date. The decision therefore extends the period for commitment of the funds until 31/12/1999 in order to allow the Community to fulfil its financial commitments as regards Cyprus. **ENTRY INTO FORCE**: the decision enters into force on 16/04/1999, while the protocol enters into force on 03/03/1999.?
