Agricultural prices 1999/2000: support system for producers of arable crops (amend. regul. 1765/92/EEC)

Prices for agricultural products 1999/2000 - Arable crops (support system): The support system for certain arable crops (cereals, oilseeds, protein plants and linseed) was introduced in 1992 and will be amended under the Agenda 2000 proposals as from 2000/2001. With regard to base areas and ceilings for irrigation for the 1999/2000 marketing year, it is proposed that where the base area is exceeded, compensatory payments be reduced proportionately (one for one). This proposal is in line with the elimination of special set-aside, as proposed in Agenda 2000.?

Agricultural prices 1999/2000: support system for producers of arable crops (amend. regul. 1765/92/EEC)

Under consultation procedure, the European Parliament approved the Commission proposal for a Council Decision derogating from Council Regulation 1765/92/EC establishing a support system for producers of certain arable crops, as regards the ceiling for irrigated land, subject to an amendment in the following area: - providing that, in the interests of consistency not only with the approach taken but also with the market situation in preceding marketing years (as well as with Agenda 2000) there is no cause to alter the set-aside rate applicable in the 1998/1999 marketing year.?

PURPOSE: Agricultural prices 1999/2000 - support system for arable crops. COMMUNITY MEASURE: Council Regulation 1672/1999/EC derogating from Regulation 1765/92/EEC establishing a support system for producers of certain arable crops, as regards the ceiling for irrigated land. CONTENT: In the interests of consistency with the approach taken in preceding marketing years and with Agenda 2000, provision should be made that, where there is an overrun of the ceiling in 1999/2000, the compensatory payments will be reduced in the same way as in the case of an overrun of a base area.?
