Prices for agricultural products 1999/2000 - Wine: Pending the decision on the reform of the common market organisation for the wine sector, which will come into force on 01/08/2000, the Commission proposes the maintenance of the guide prices for table wine at their current levels for the 1999/2000 marketing year, i.e.: - wine type RI : EUR 3,828/% vol/hl - wine type RII : EUR 3,828/% vol/hl - wine type RIII: EUR 62,15/hl - wine type AI : EUR 3,828/% vol/hl - wine type AII : EUR 82,81/hl - wine type AIII: EUR 94,57/hl.?

PURPOSE: 1999/2000 agricultural prices - Wine (guide price). COMMUNITY MEASURE: Council Regulation 1676/1999/EC fixing the guide price for wine for the 1999/2000 wine year. CONTENT: The Council has decided to keep the guide prices for table wines at their existing level for the 1999/2000 wine year. They are as follows: - Wine type R I : EUR 3.828/% vol/hl - Wine type R II: EUR 3.828/% vol/hl - Wine type R III: EUR 62.15/hl - Wine type A I: EUR 3.828/% vol/hl - Wine type A II: EUR 82.8/hl - Wine type A III: EUR 94.57/hl ENTRY INTO FORCE: 30.07.1999. The Regulation shall apply from 1 September 1999.?
